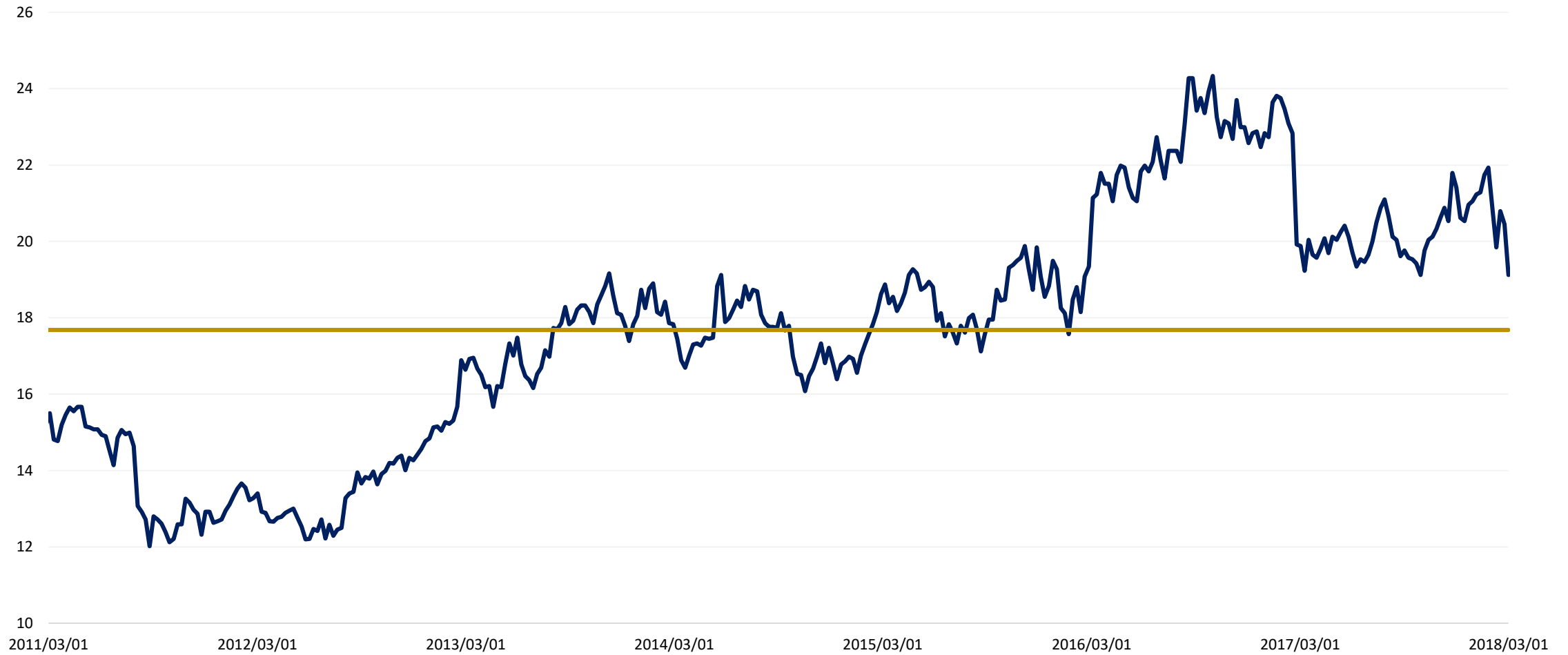

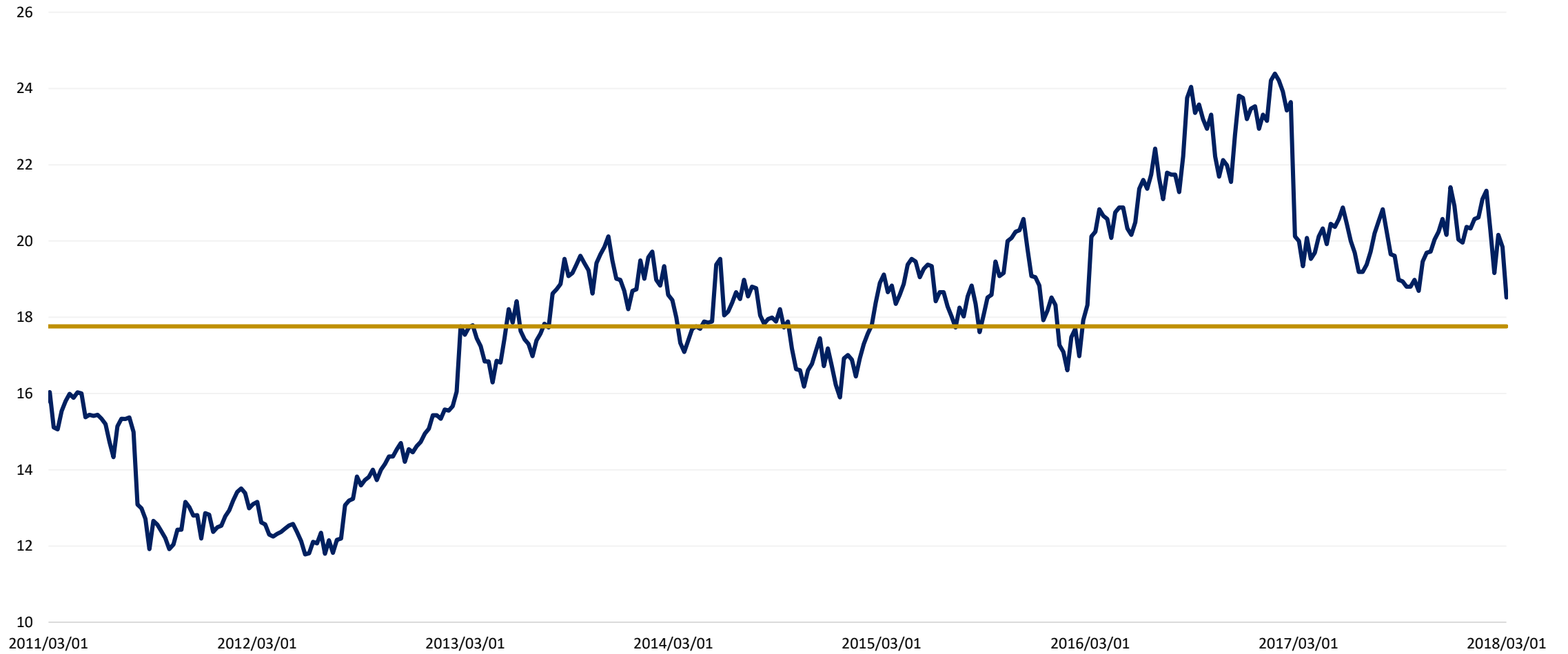

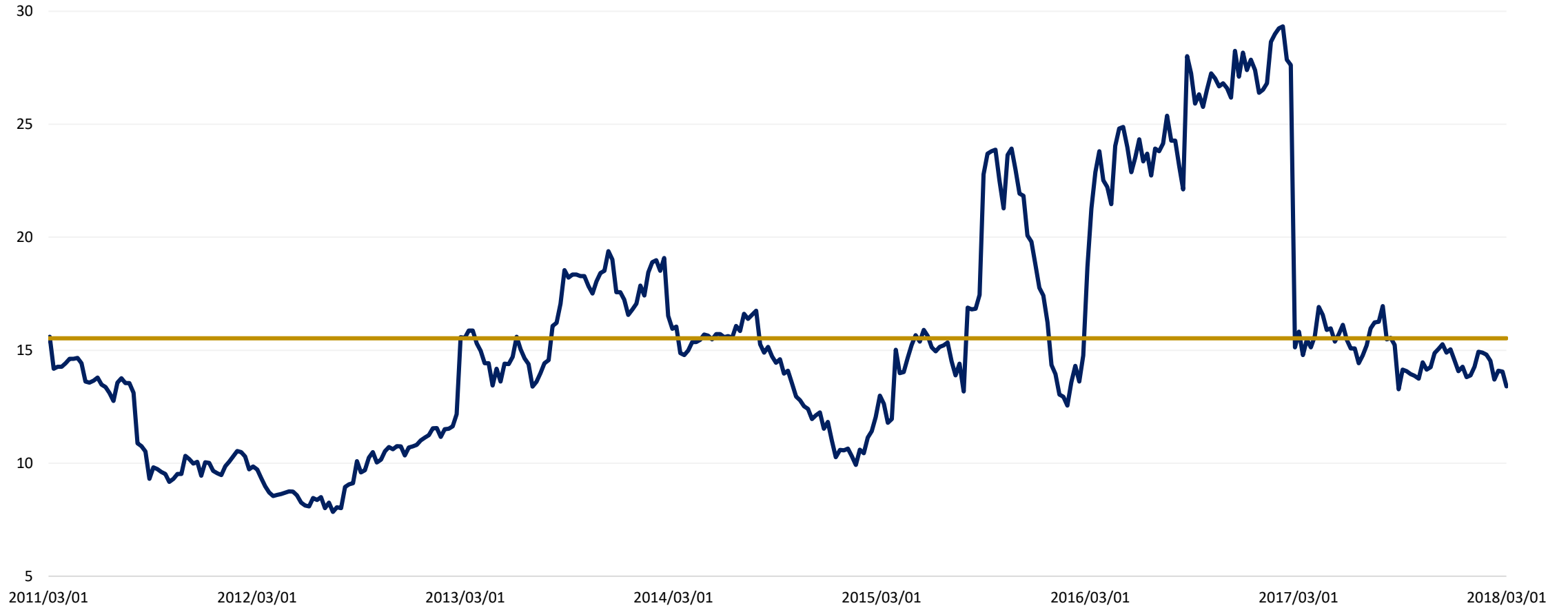

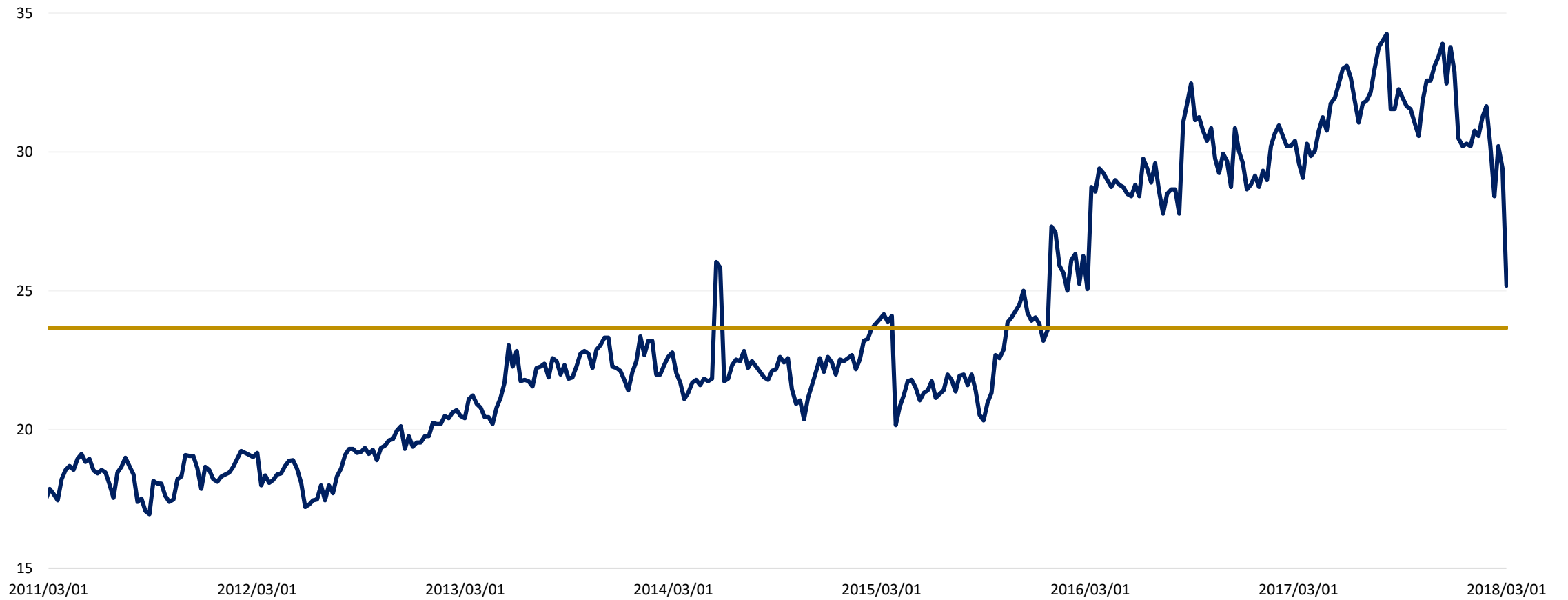

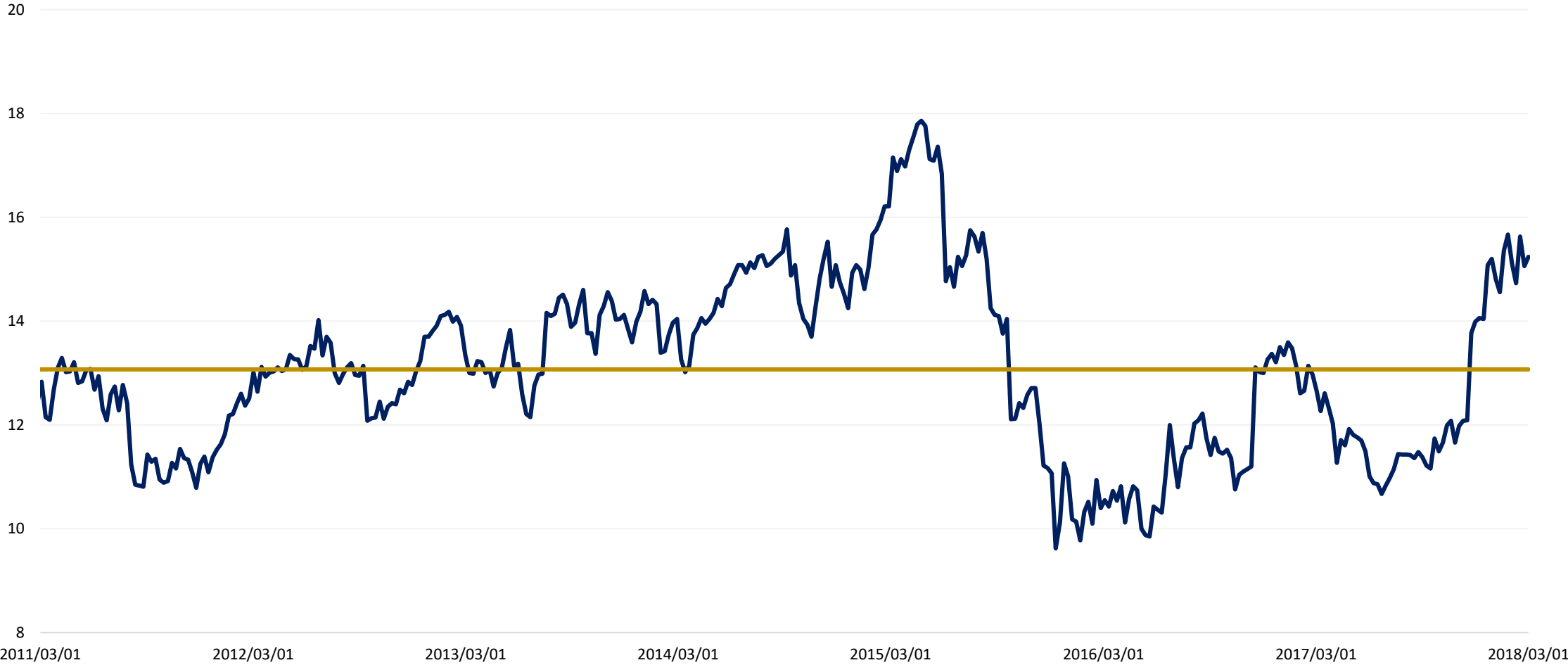

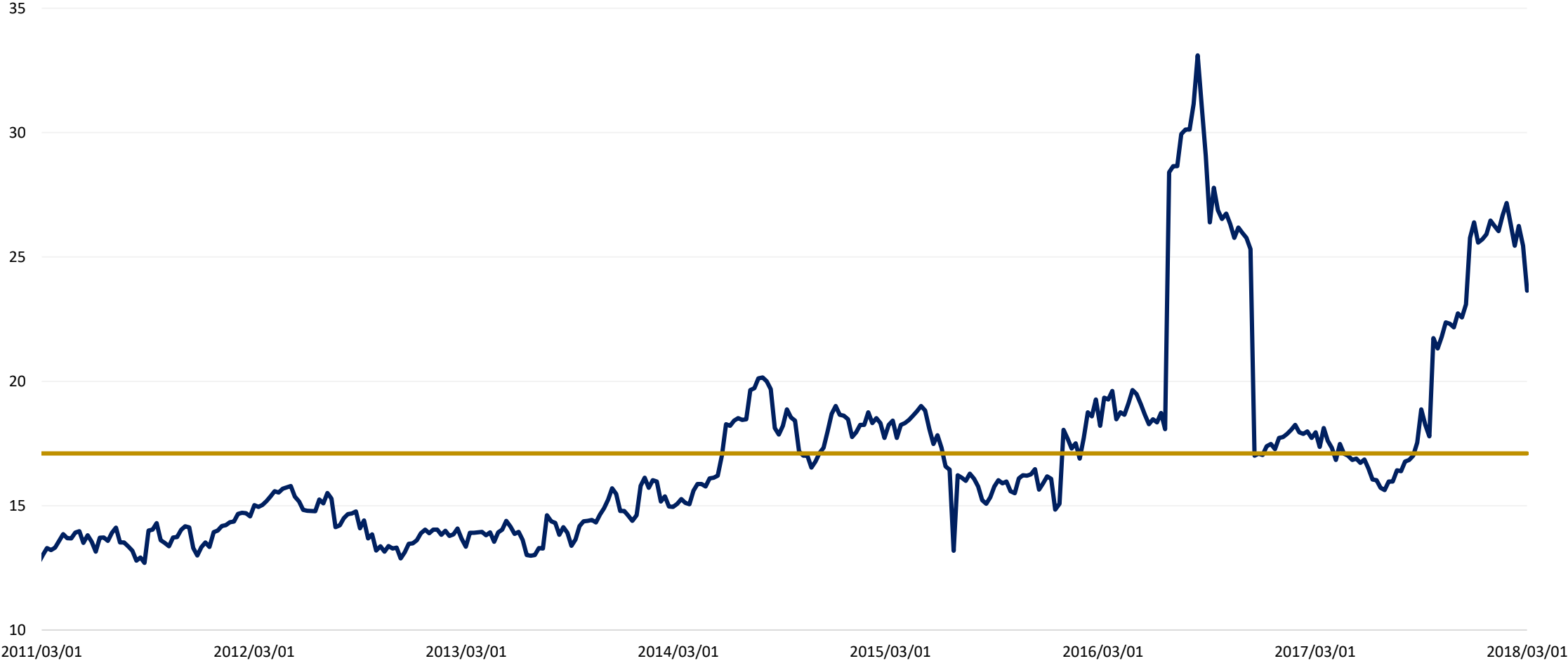

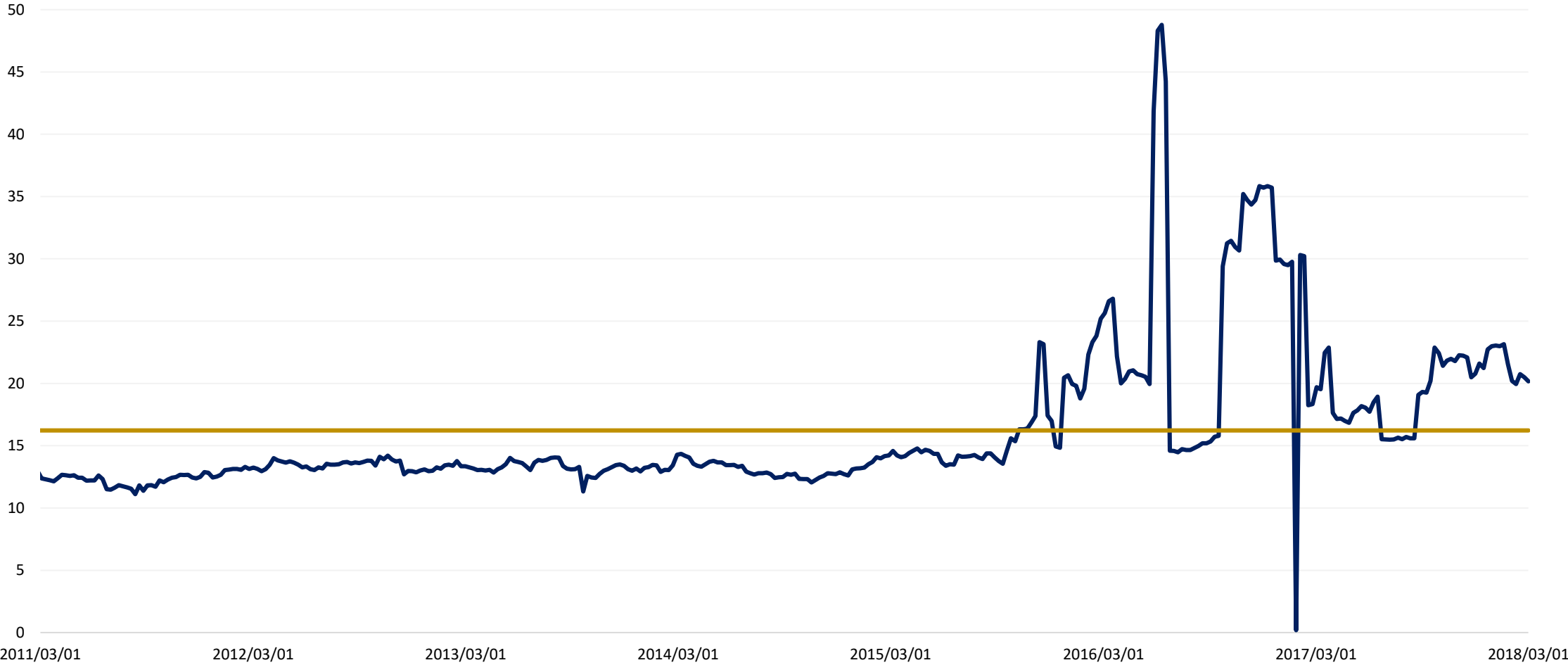

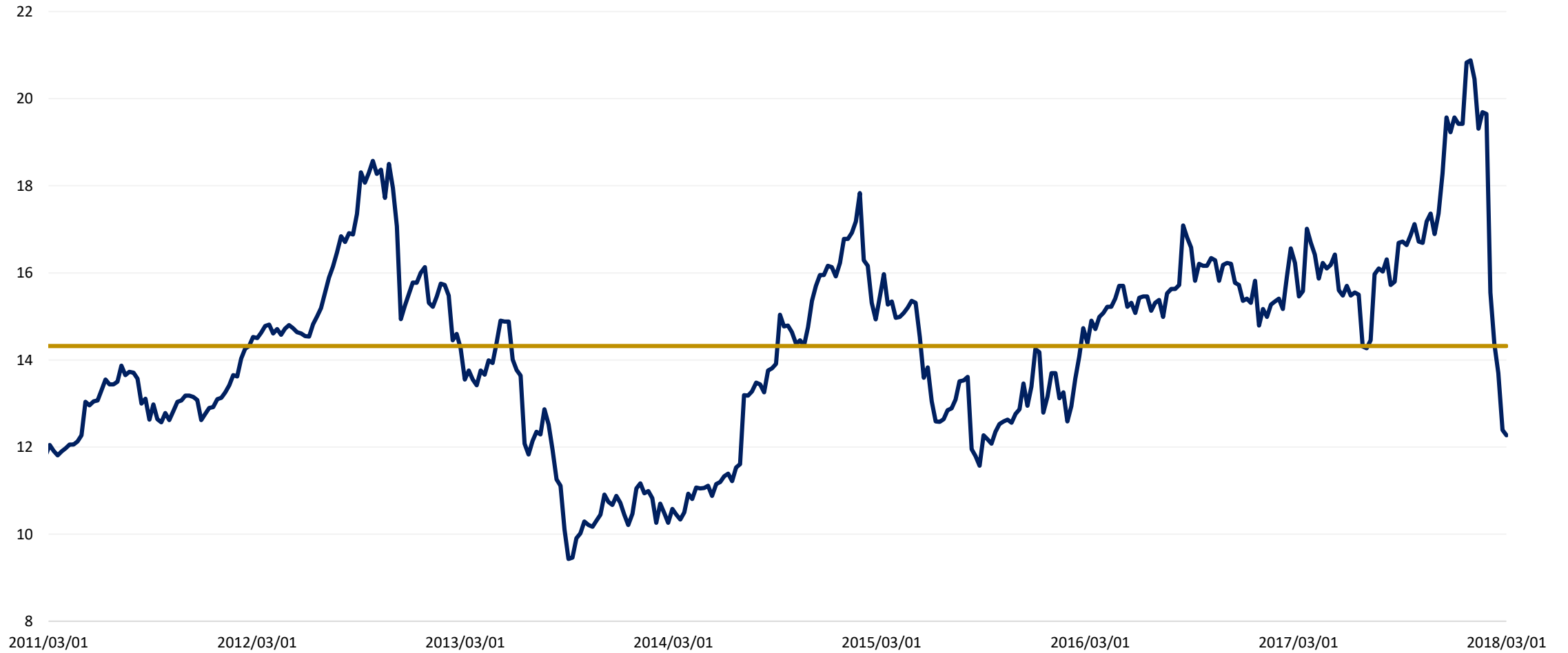

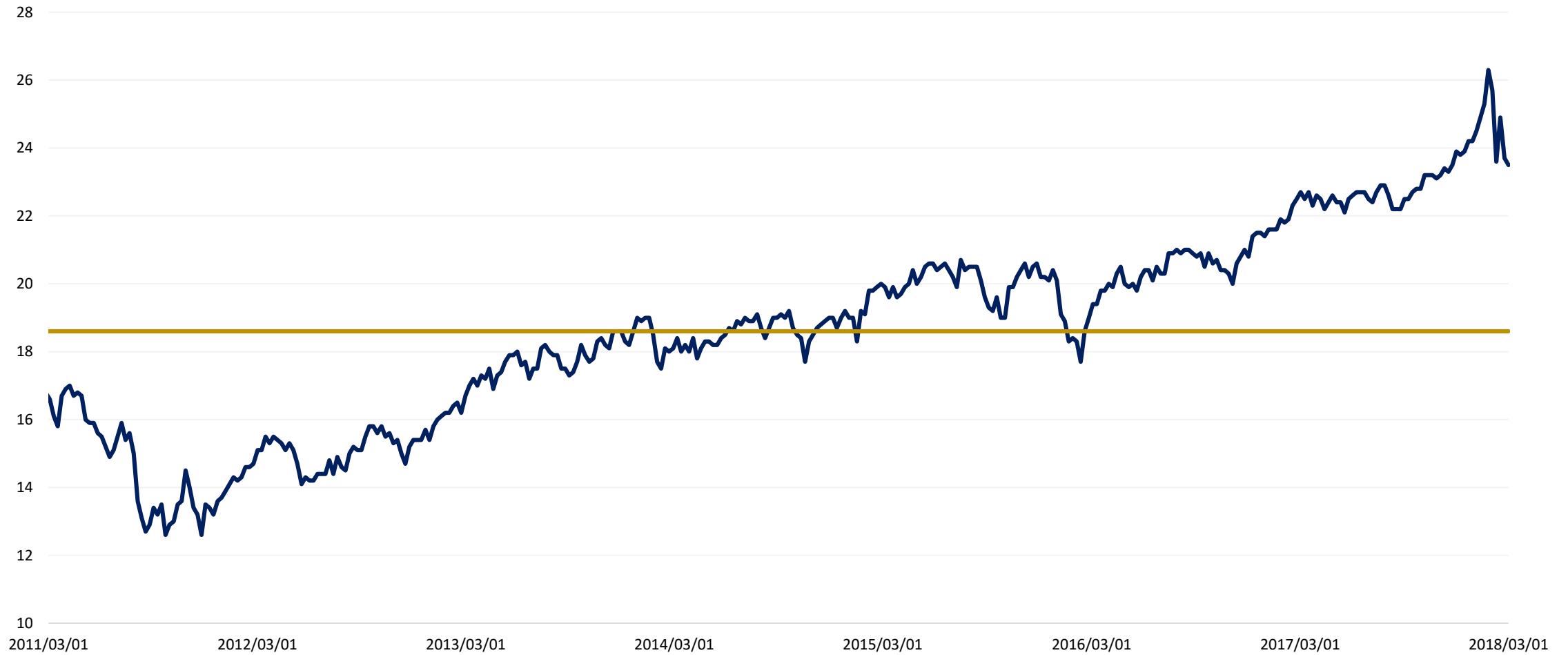

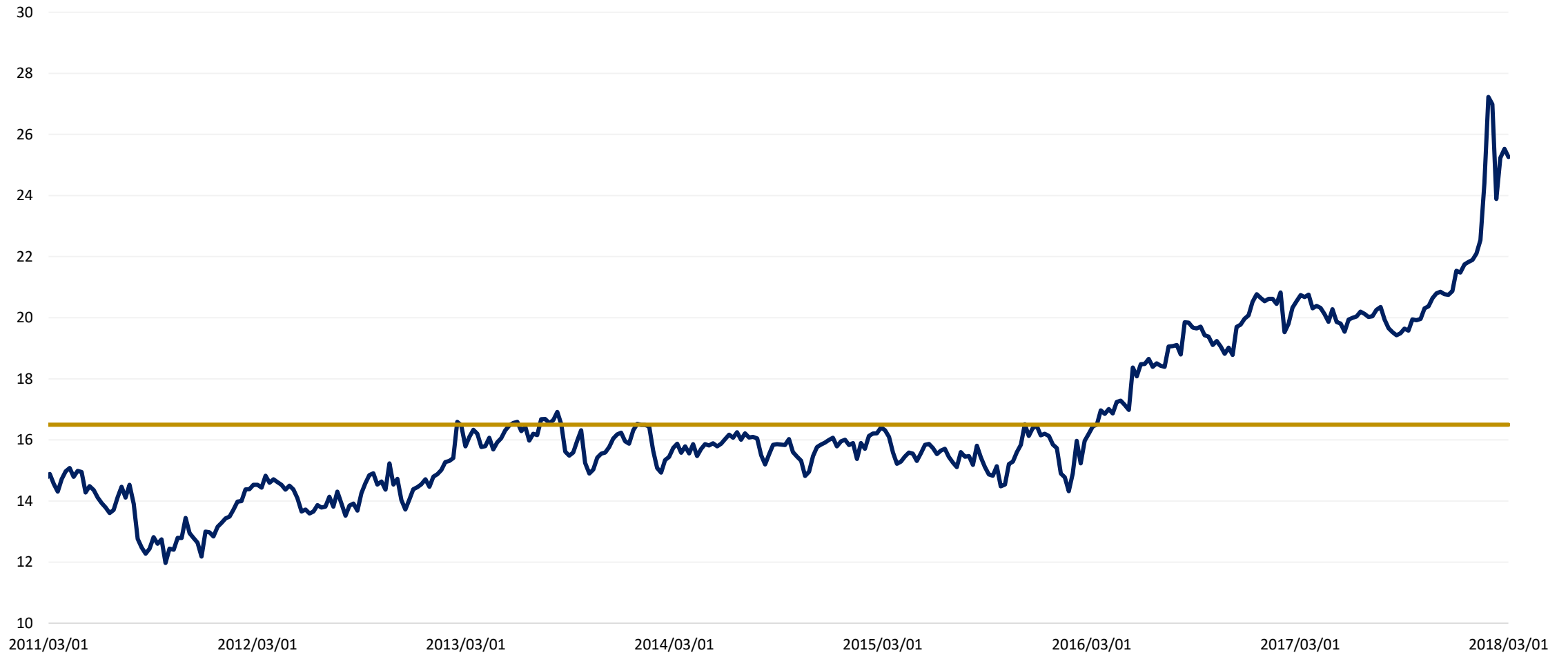

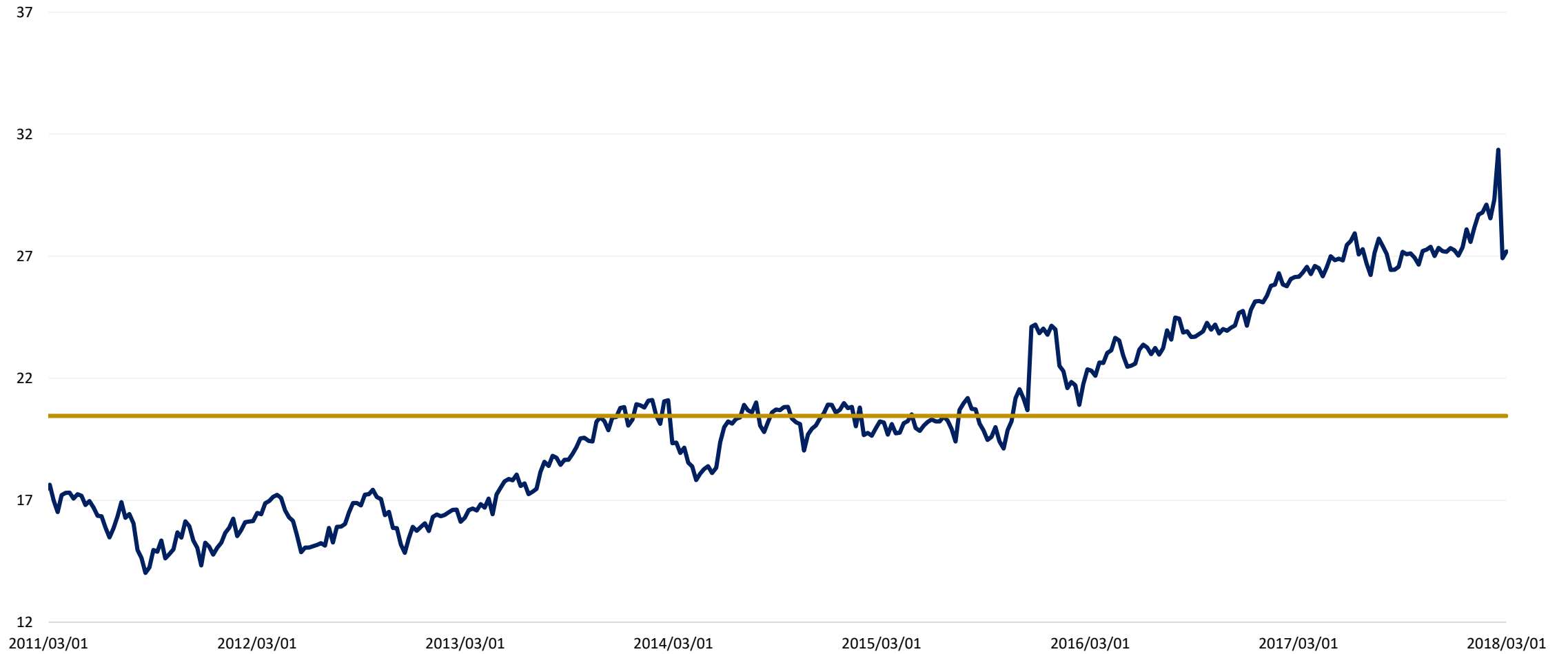

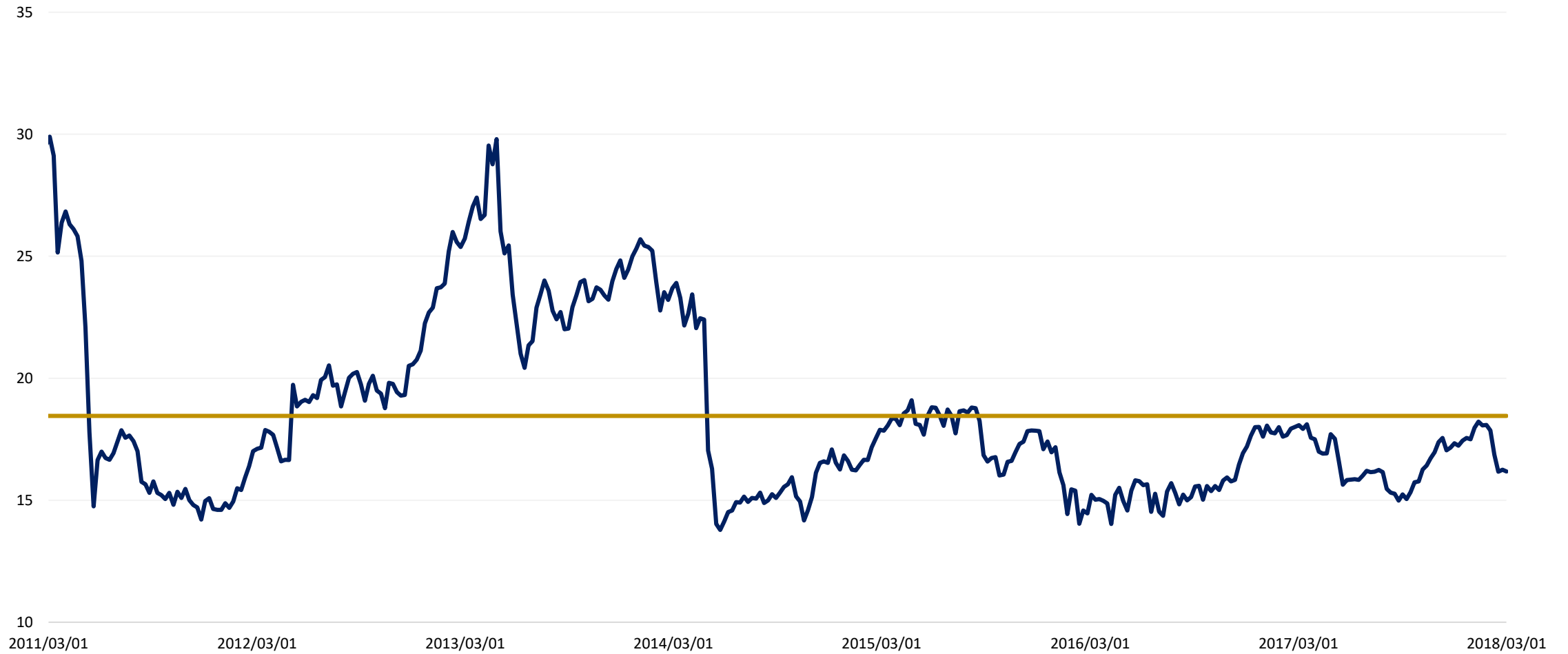

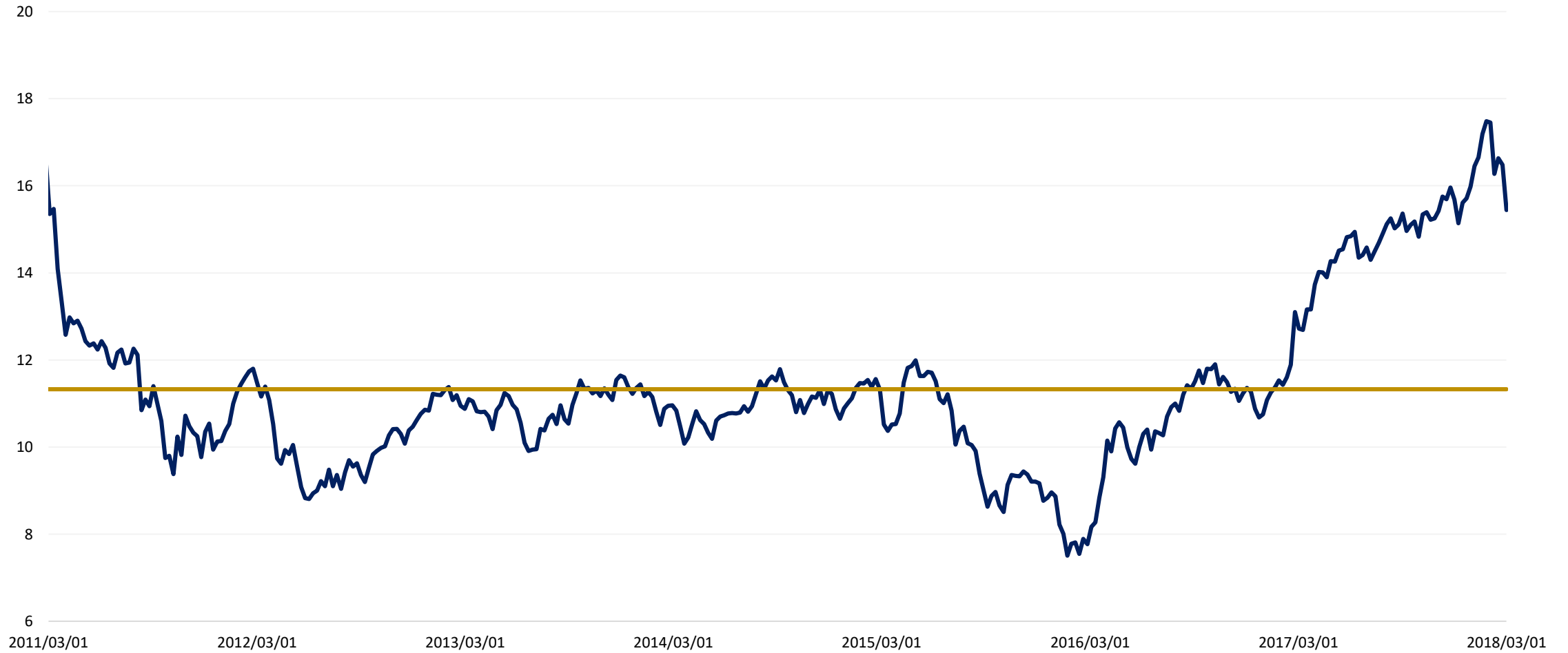

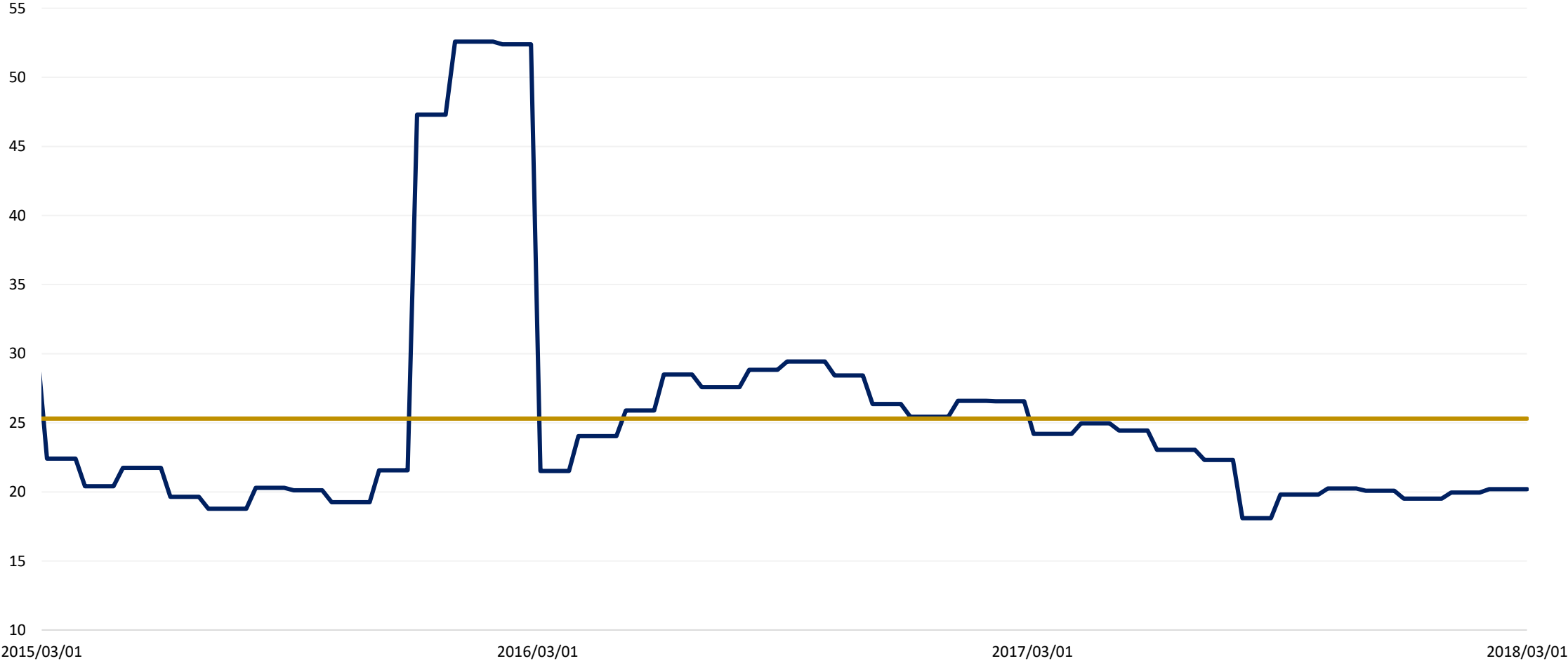

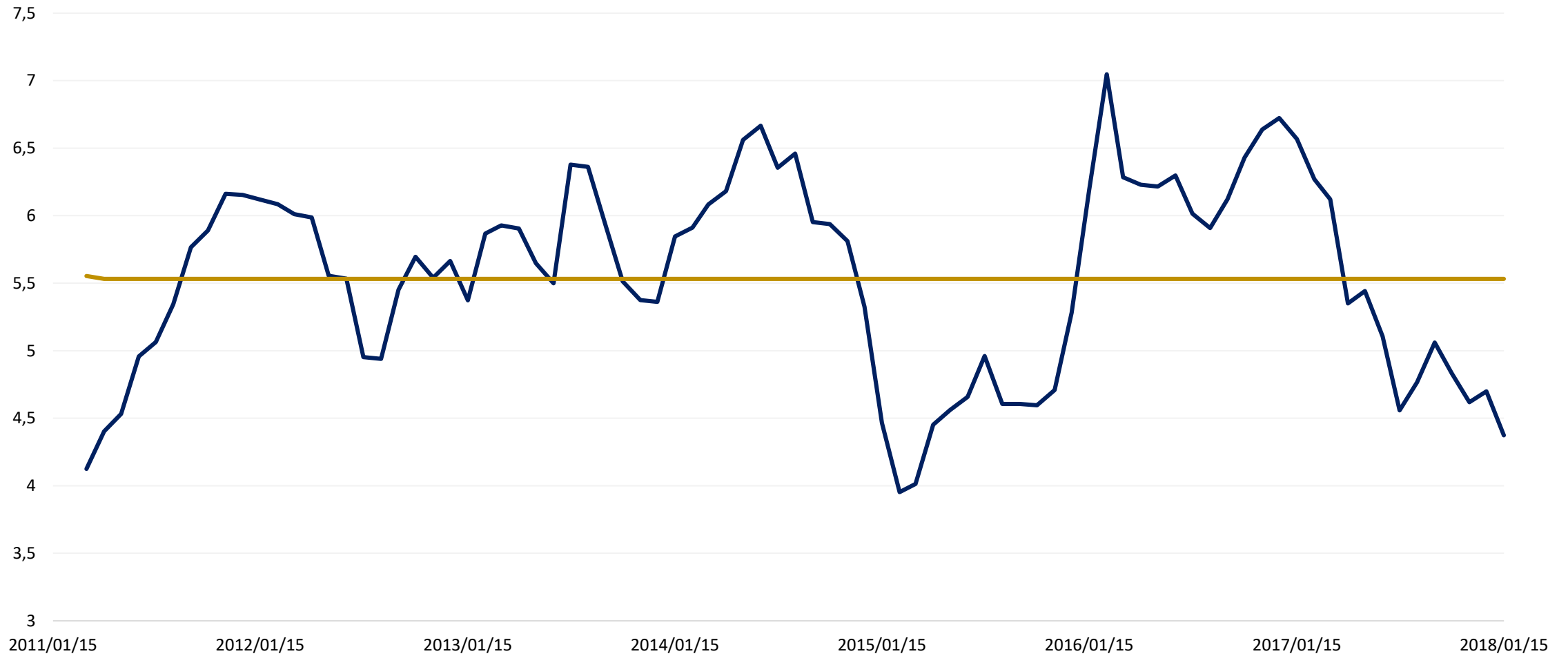

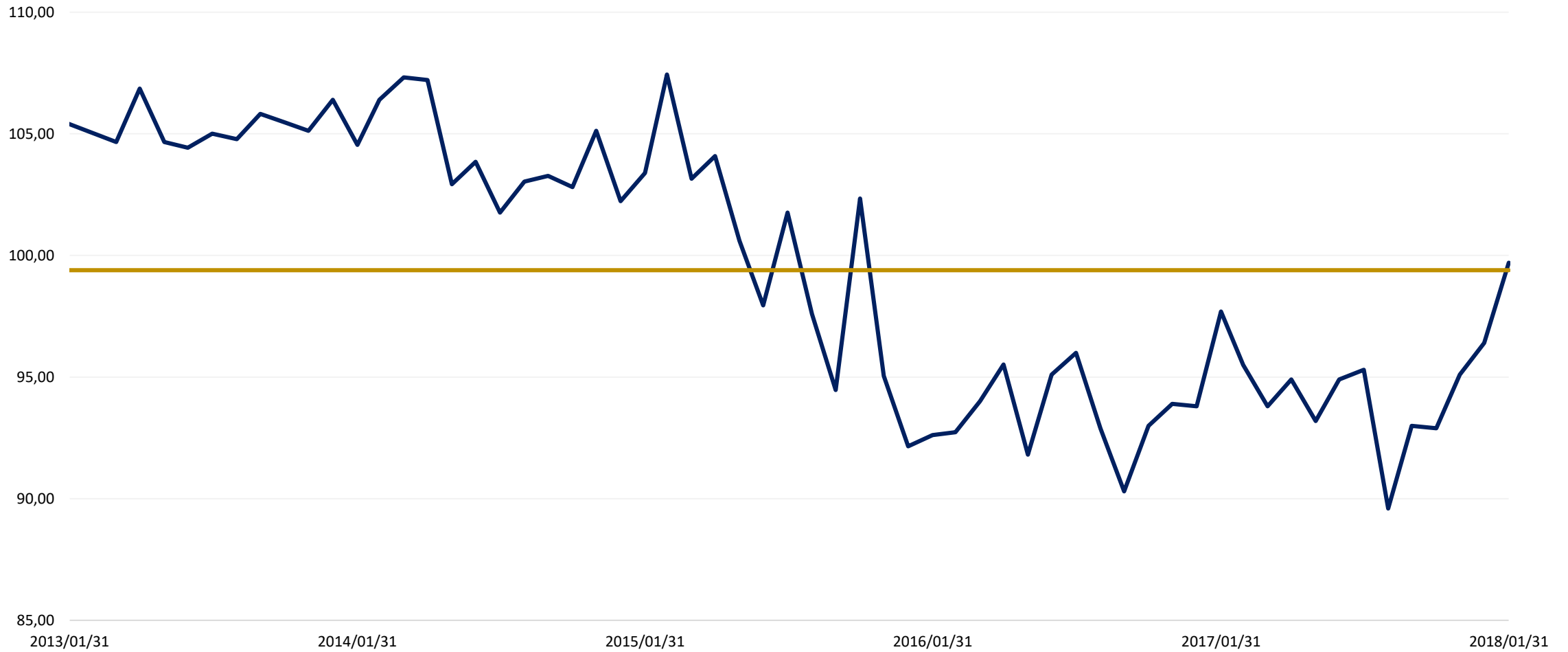

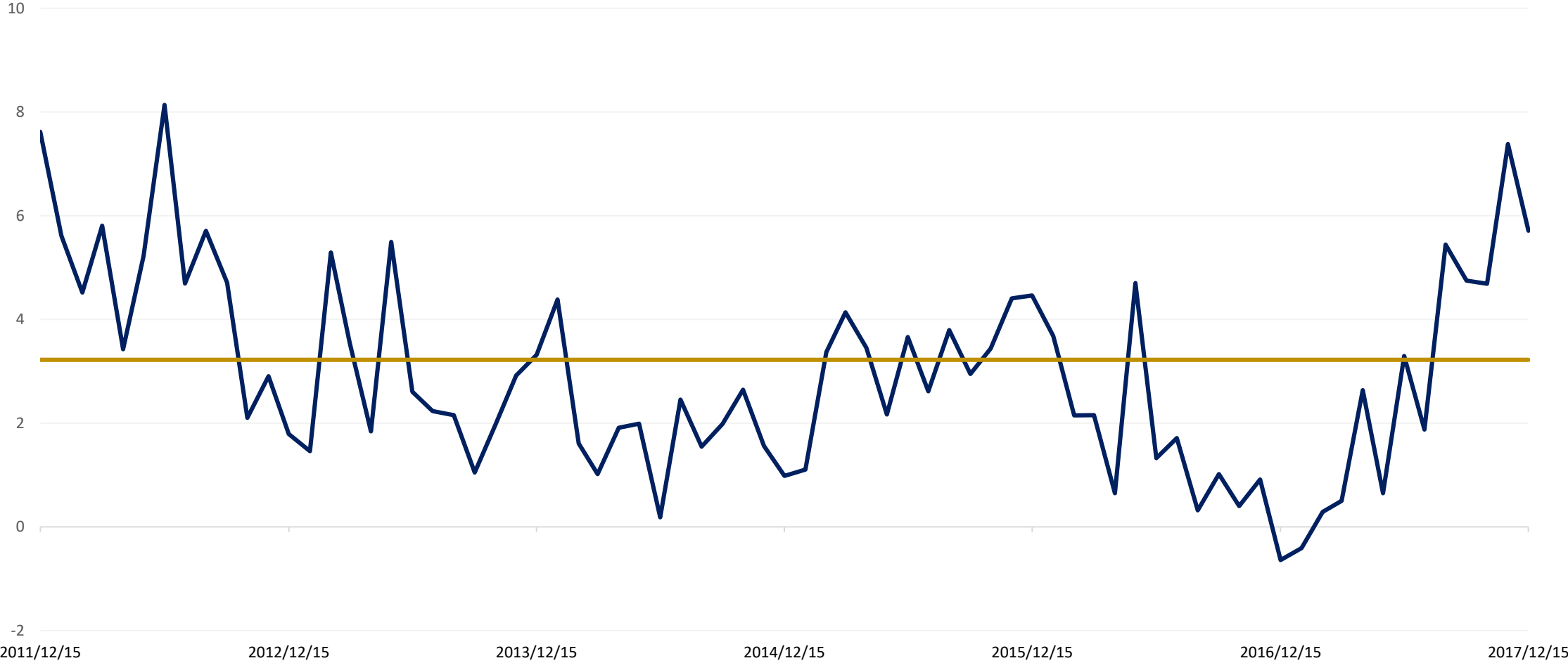

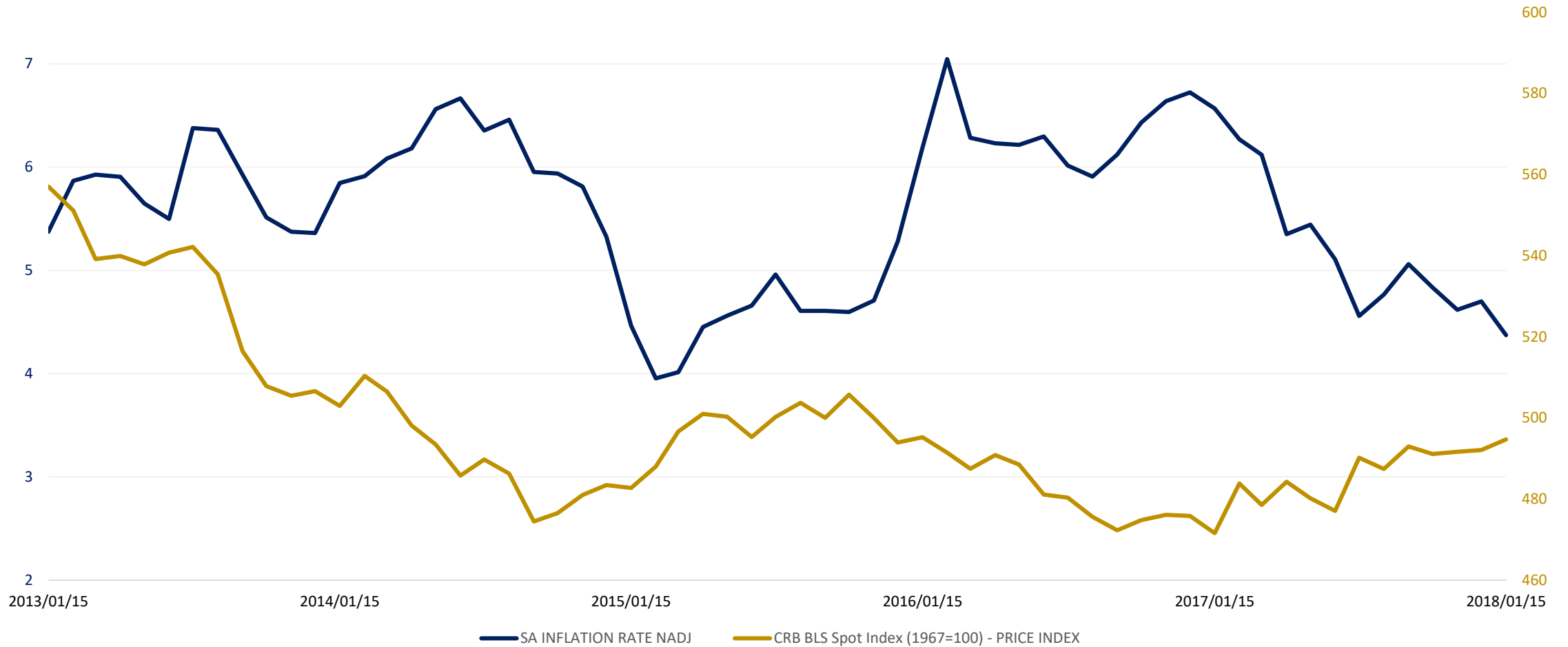
SA Retail Sales YoY Growth (%)

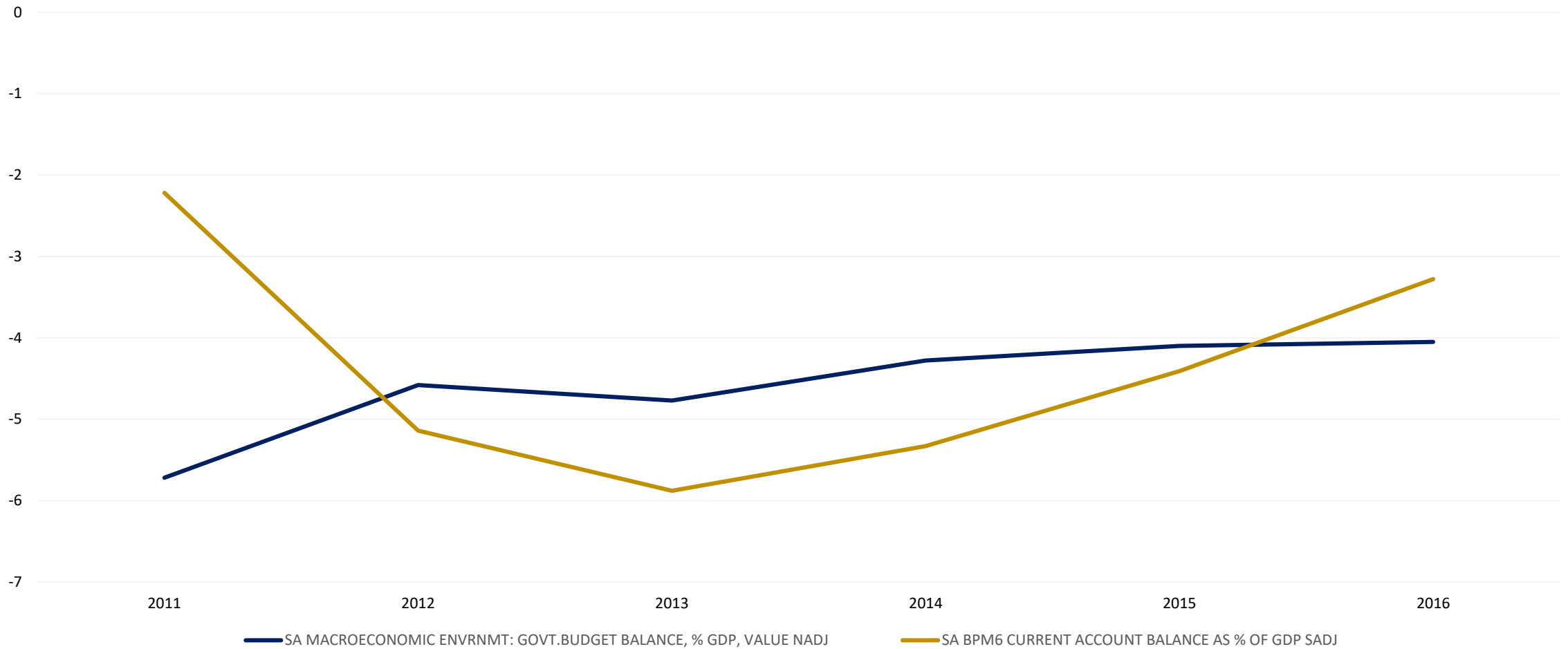


SA CPI vs CRB INDEX

10-Year Price and Growth

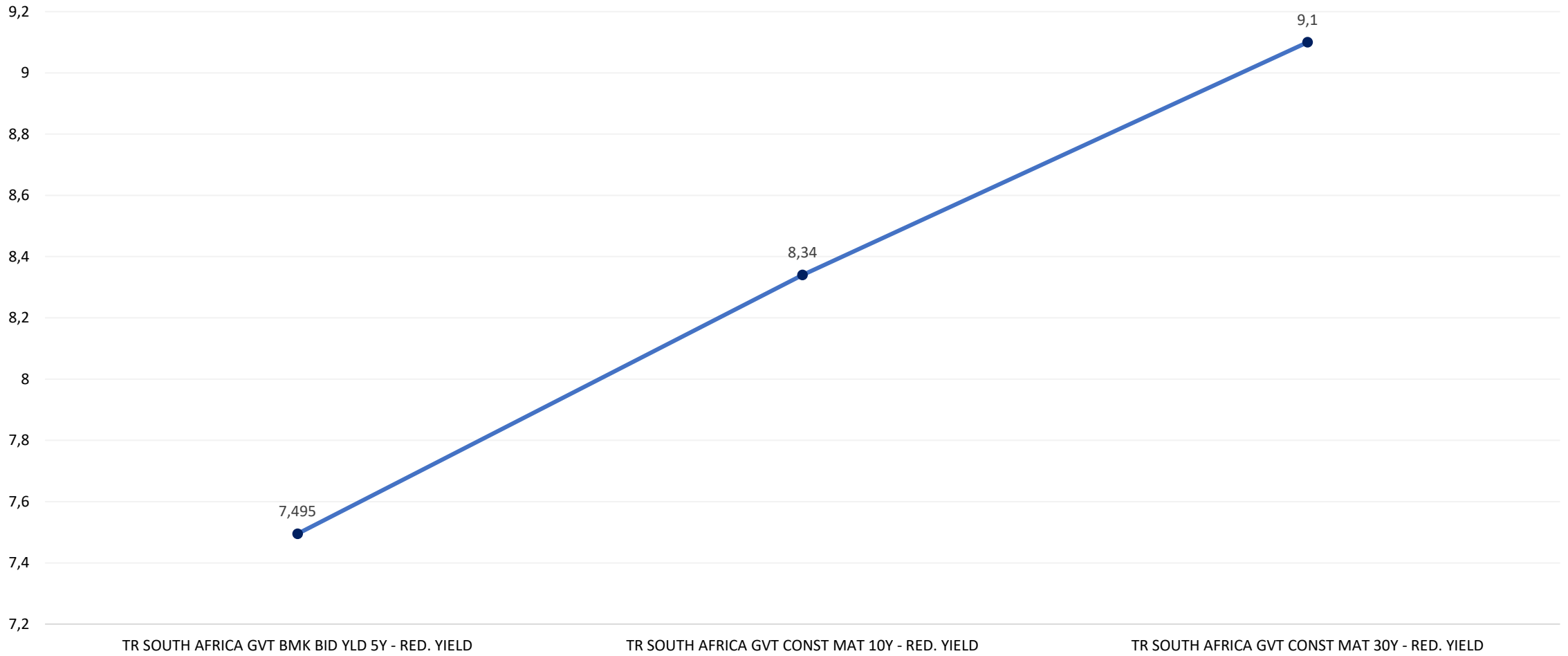


SA Budget and Current Account Balance (% of GDP)



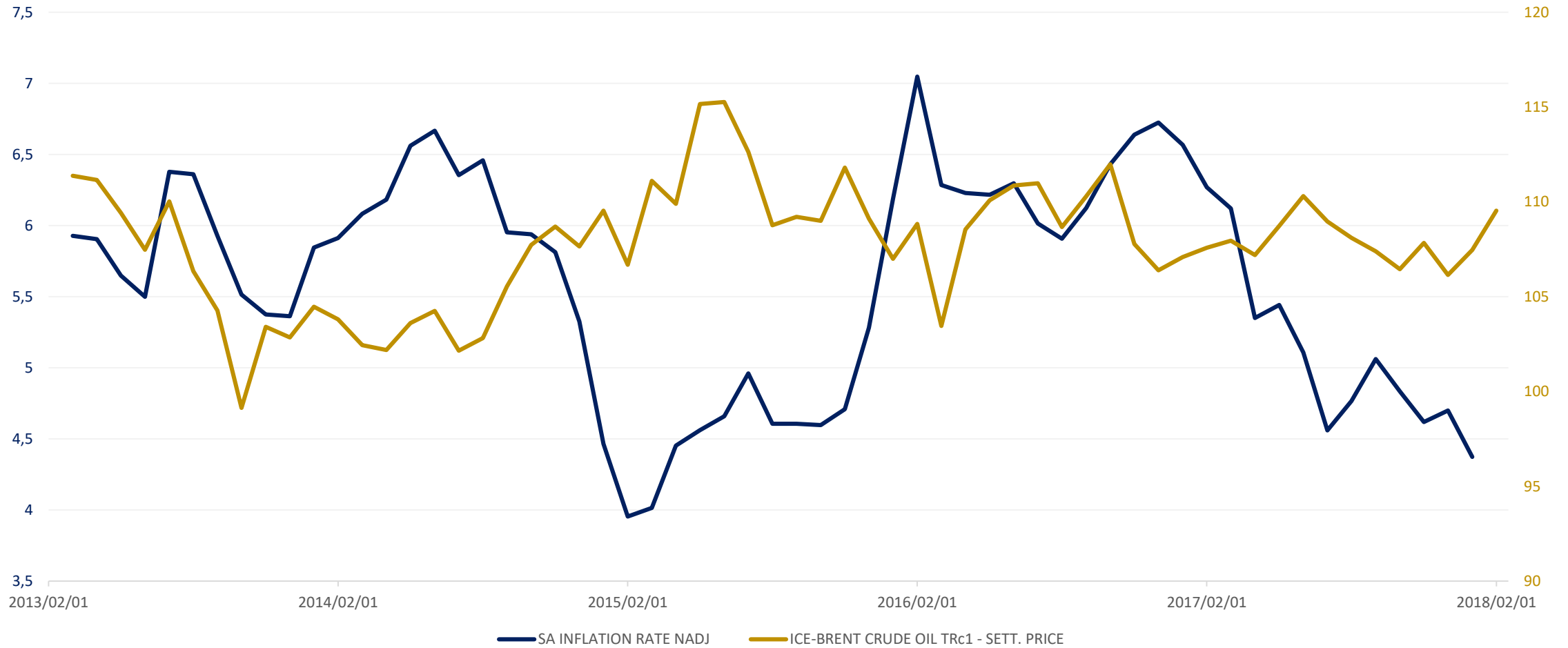
SA Bond Yields

SA Inflation Rate vs ICE Brent Crude

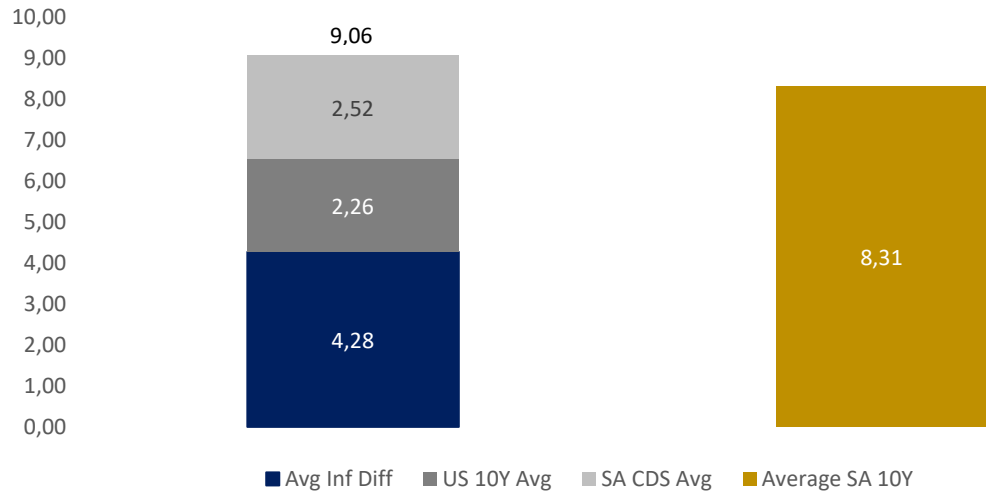

Implied SA 10 Year Bond Yield vs Actual Yield

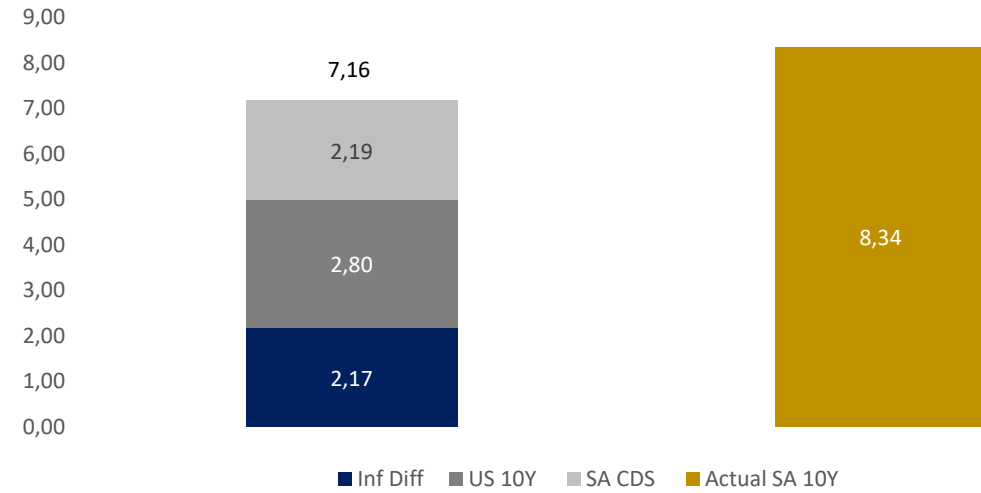

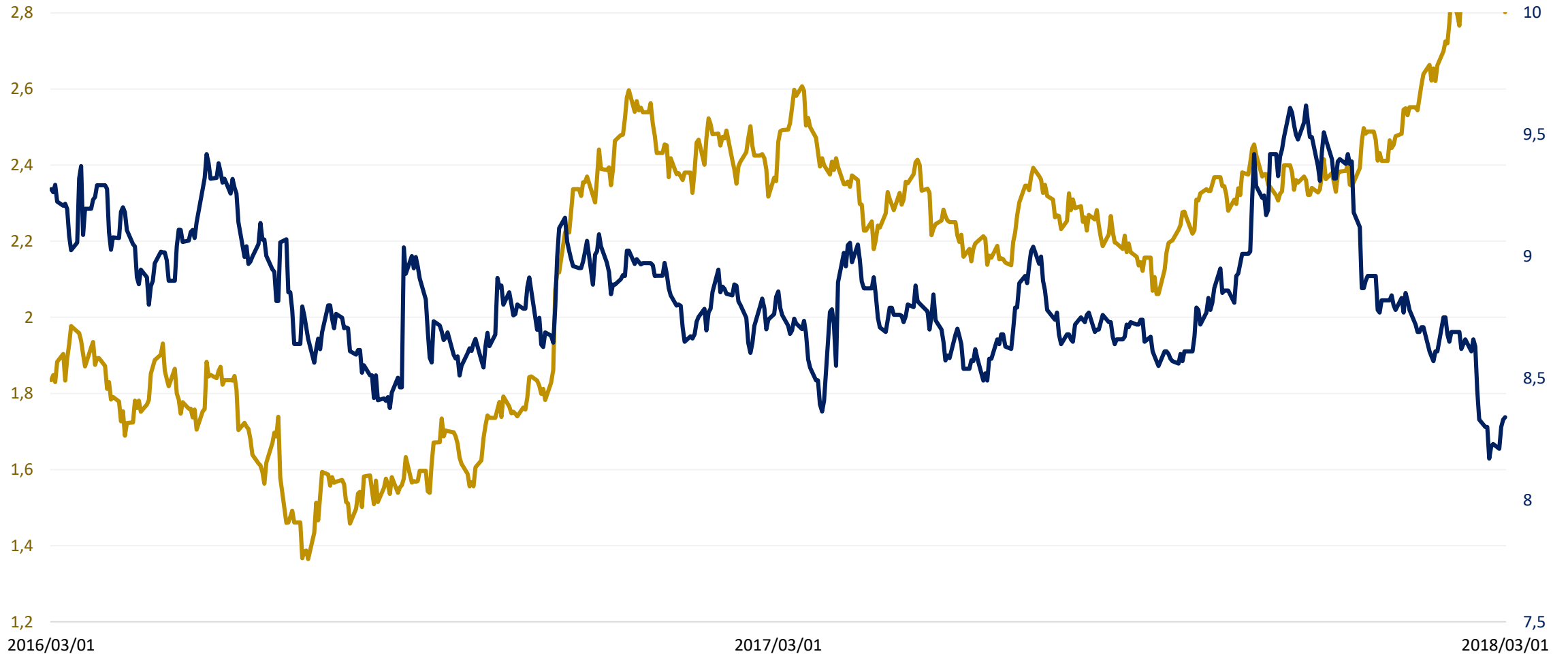

US 10 Year vs SA 10 Year

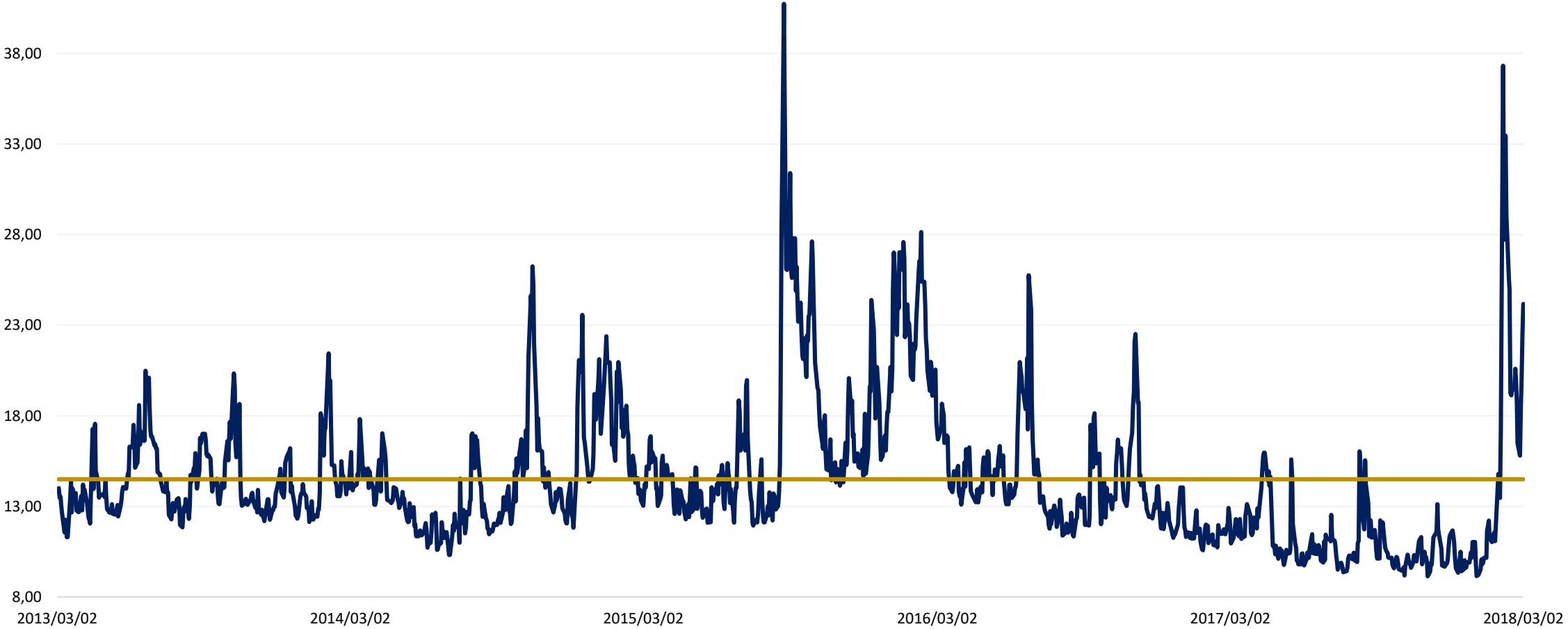

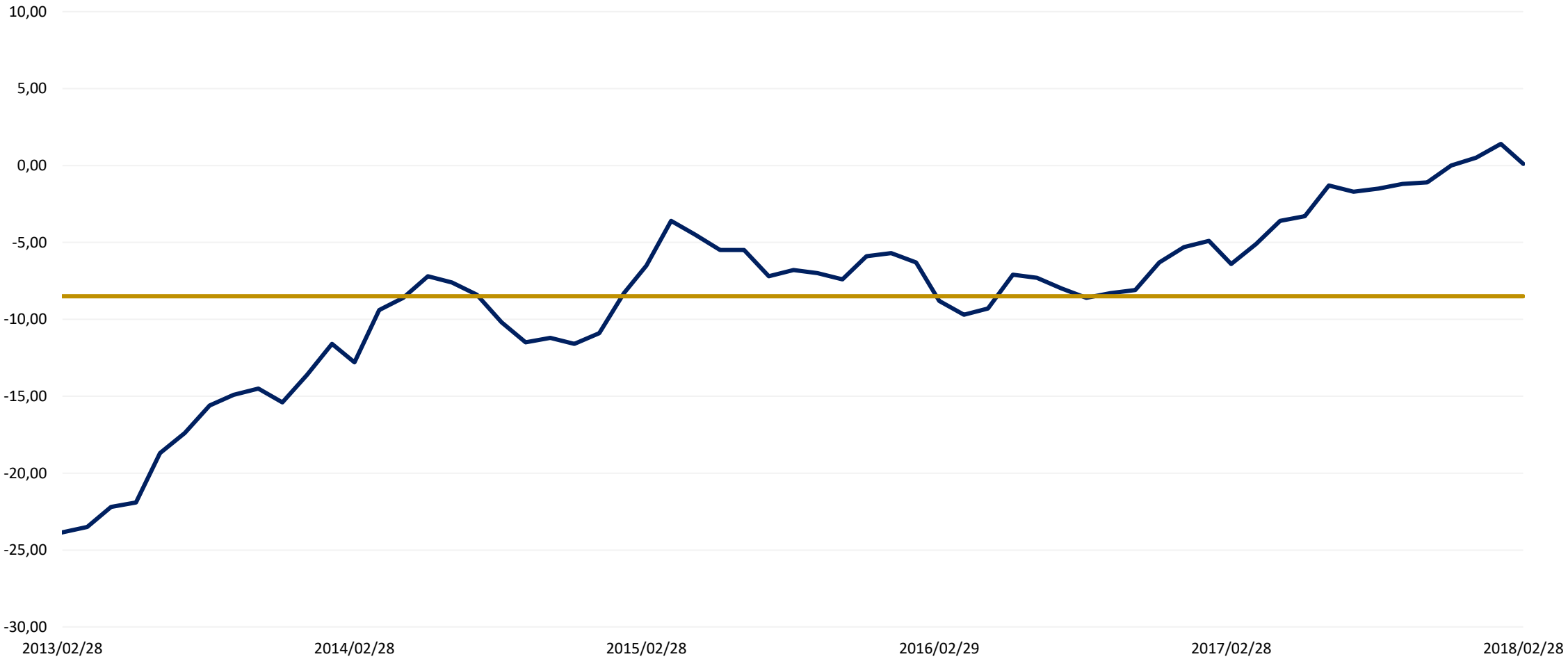

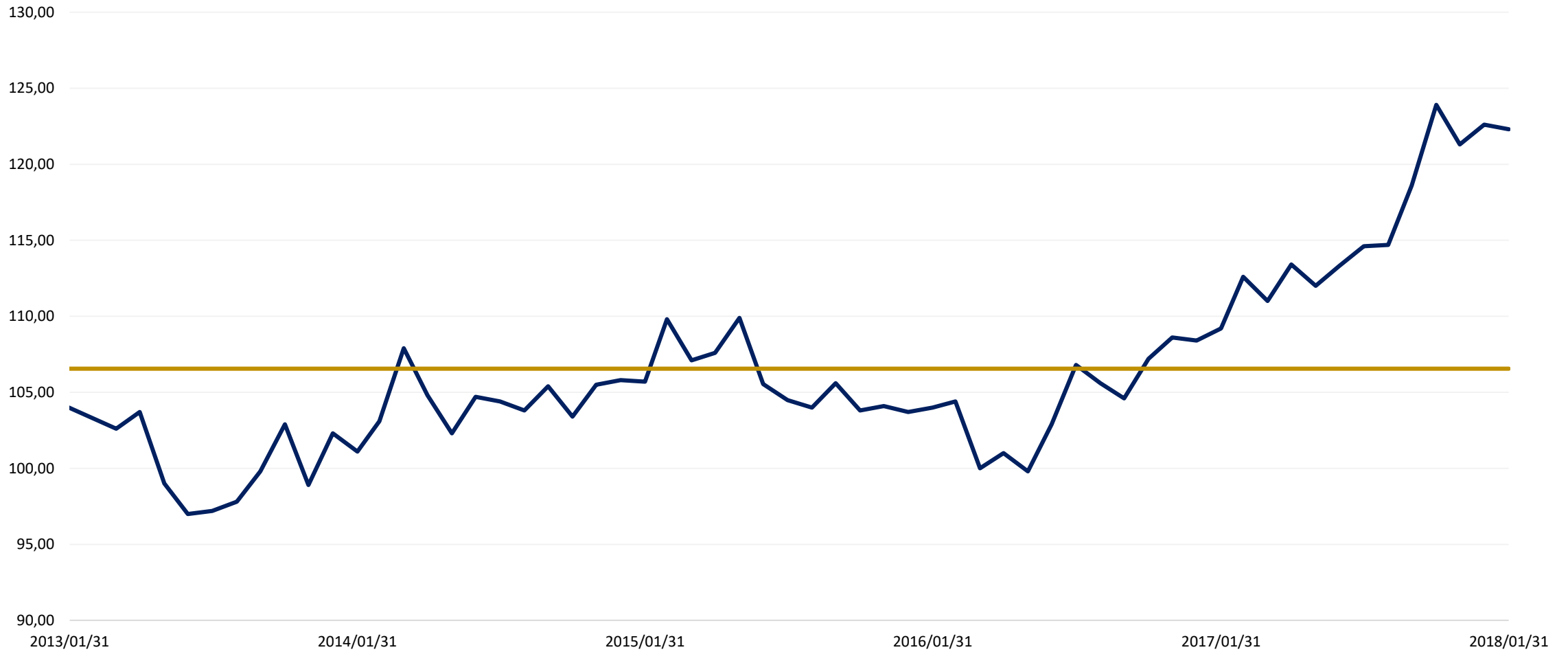
Euro Zone - Consumer Confidence

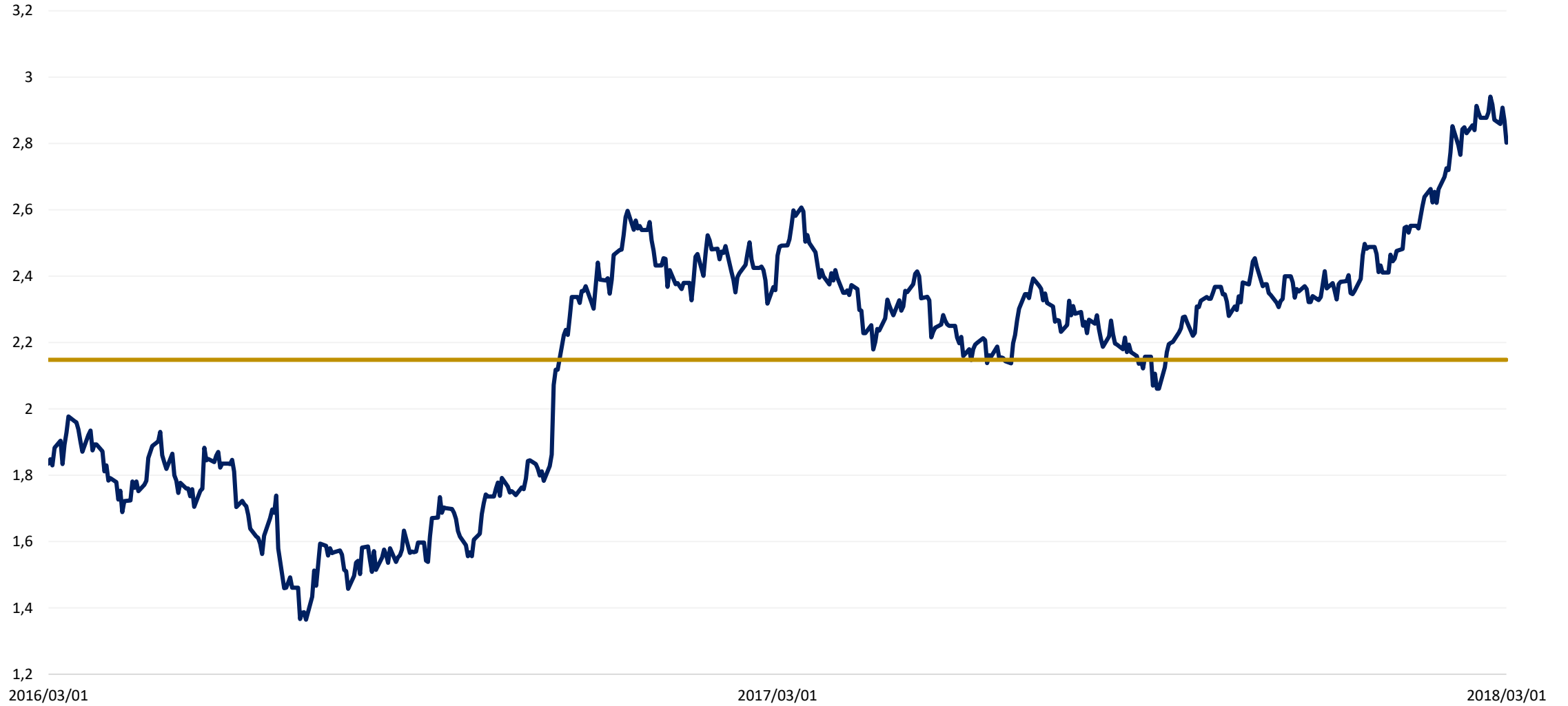


China (Mainland) – Consumer Confidence

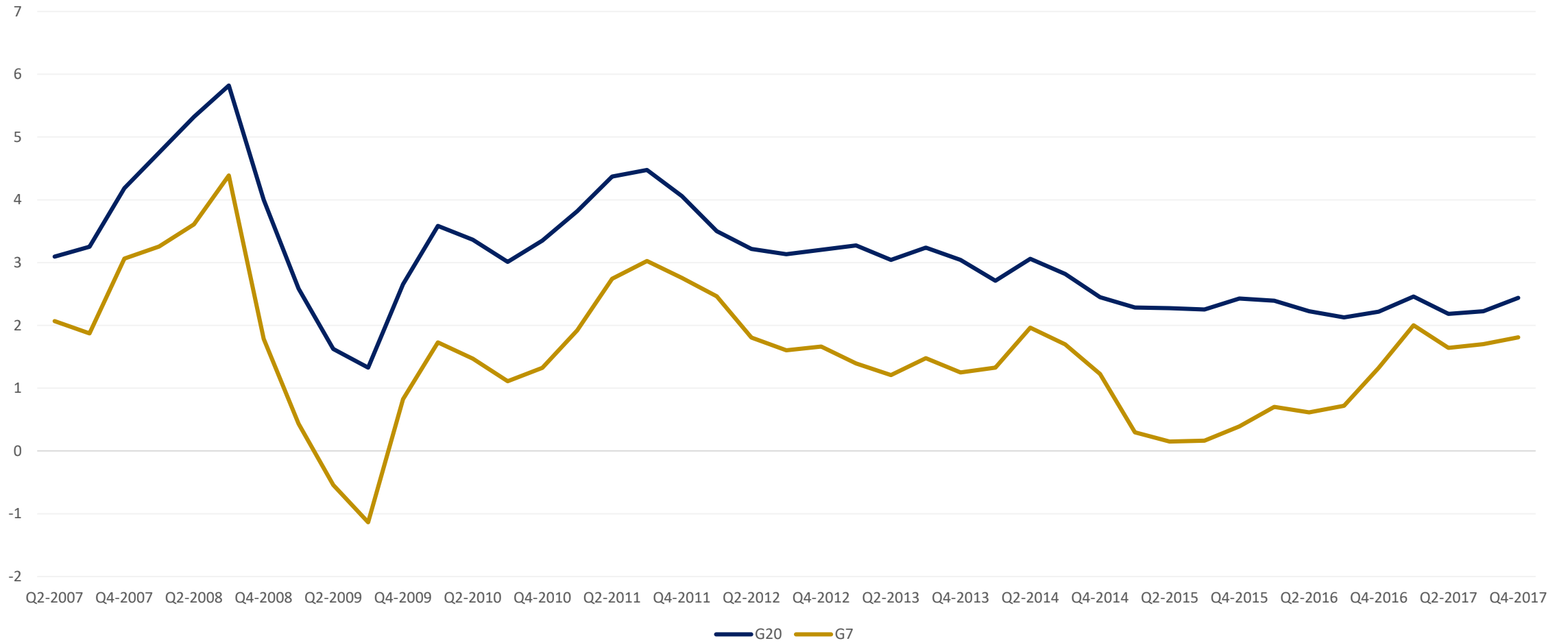


US 10 Year Yield



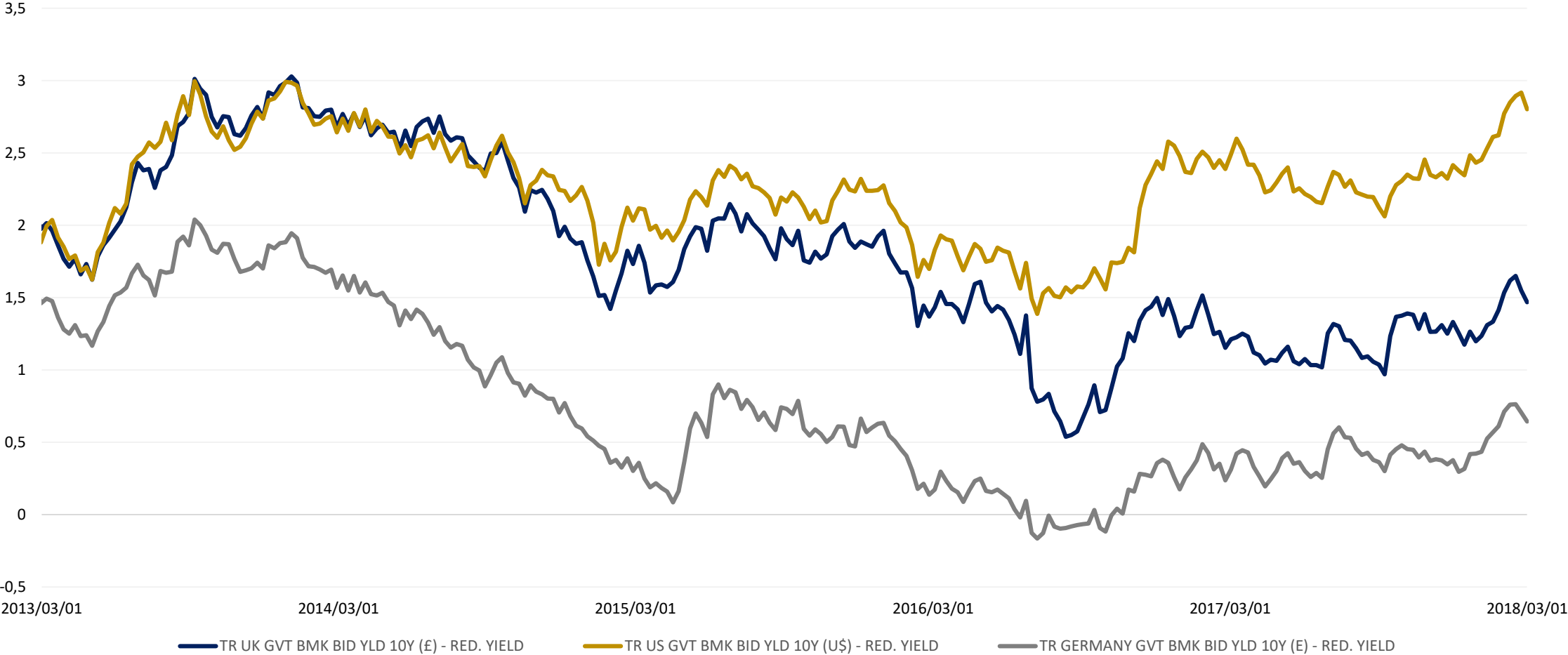
G20 CPI vs G7 CPI (%)

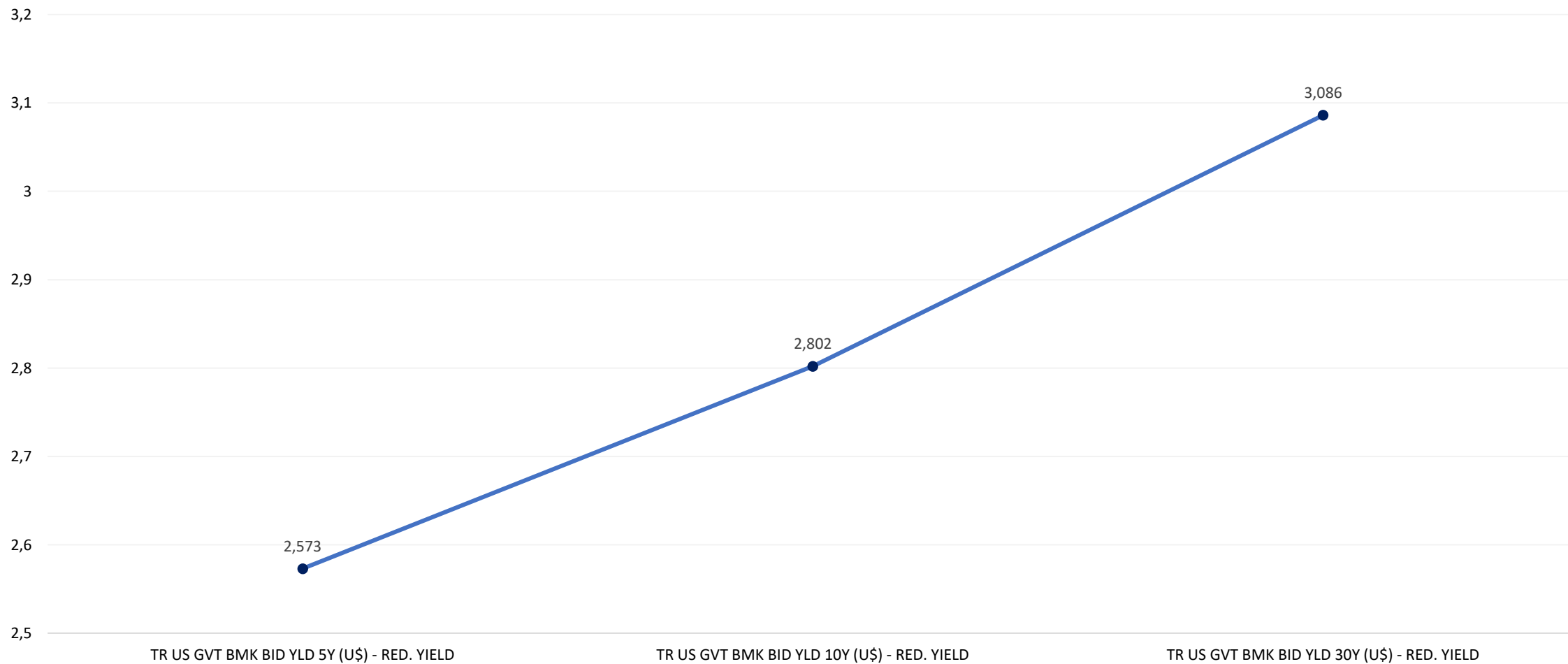

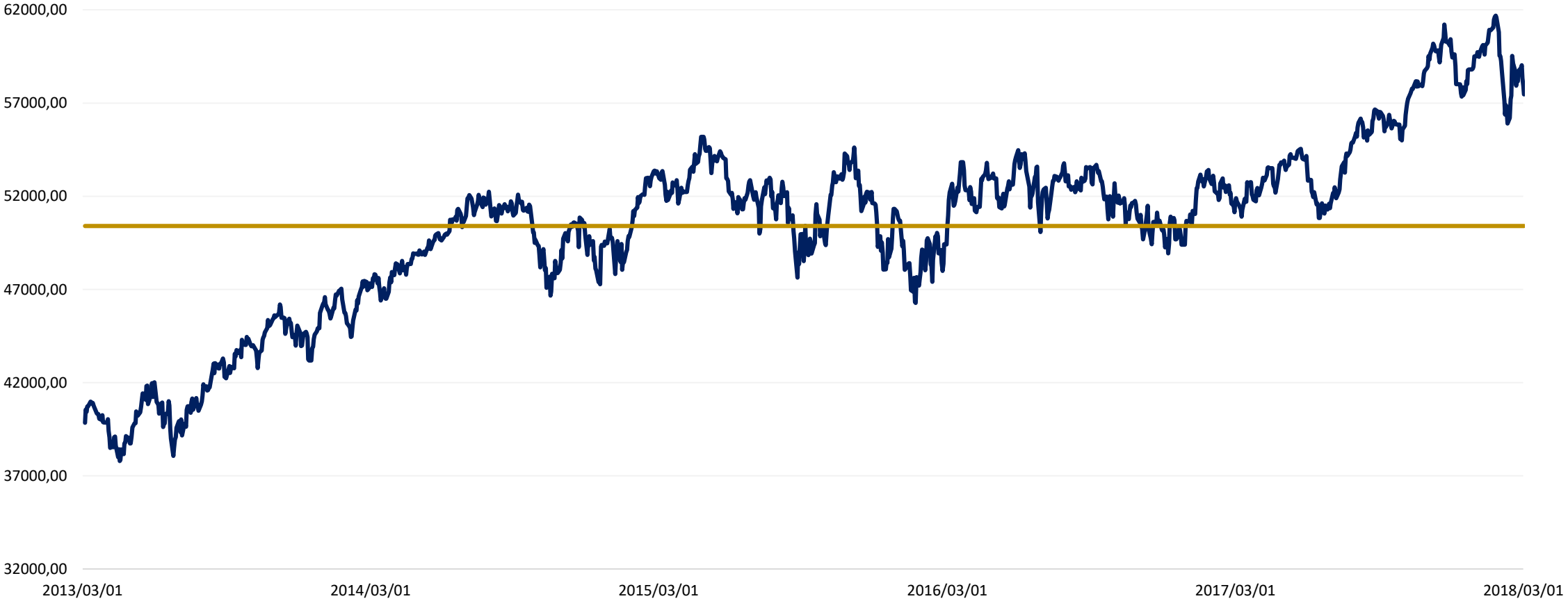

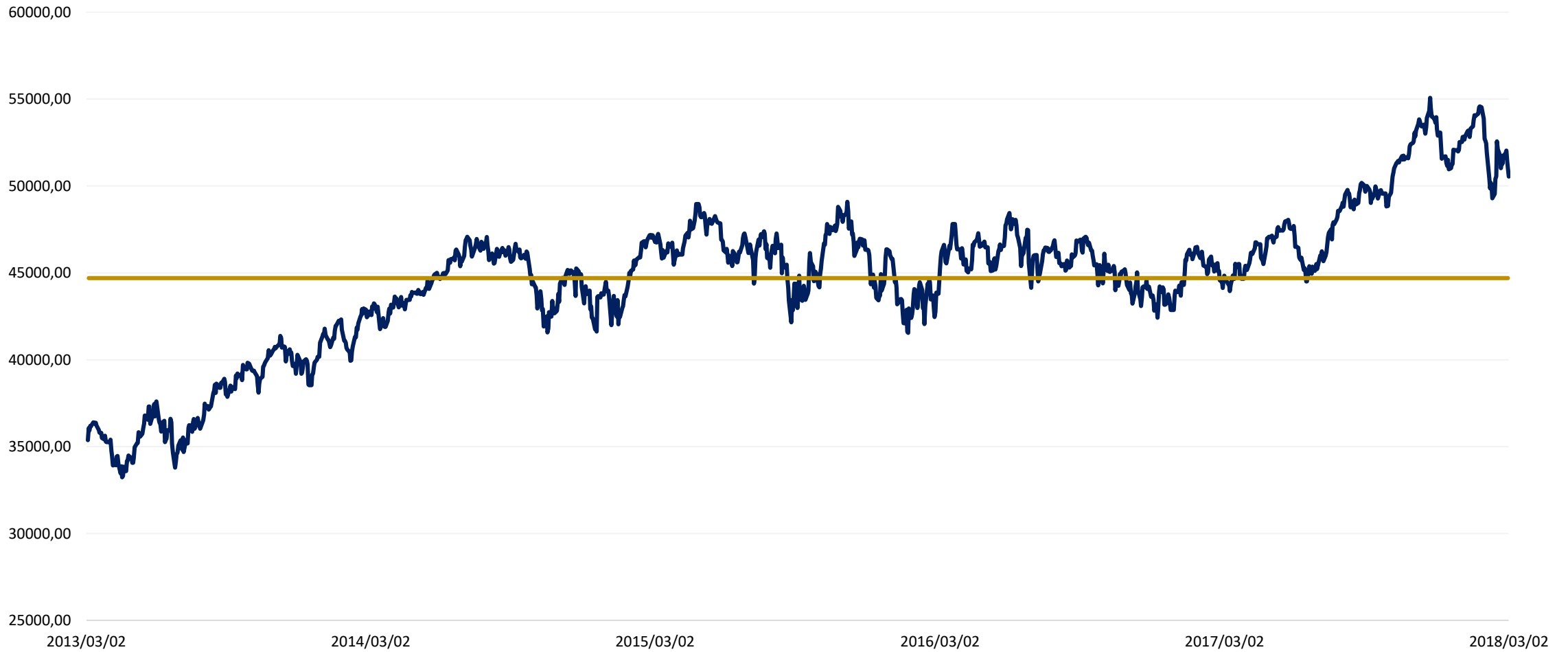

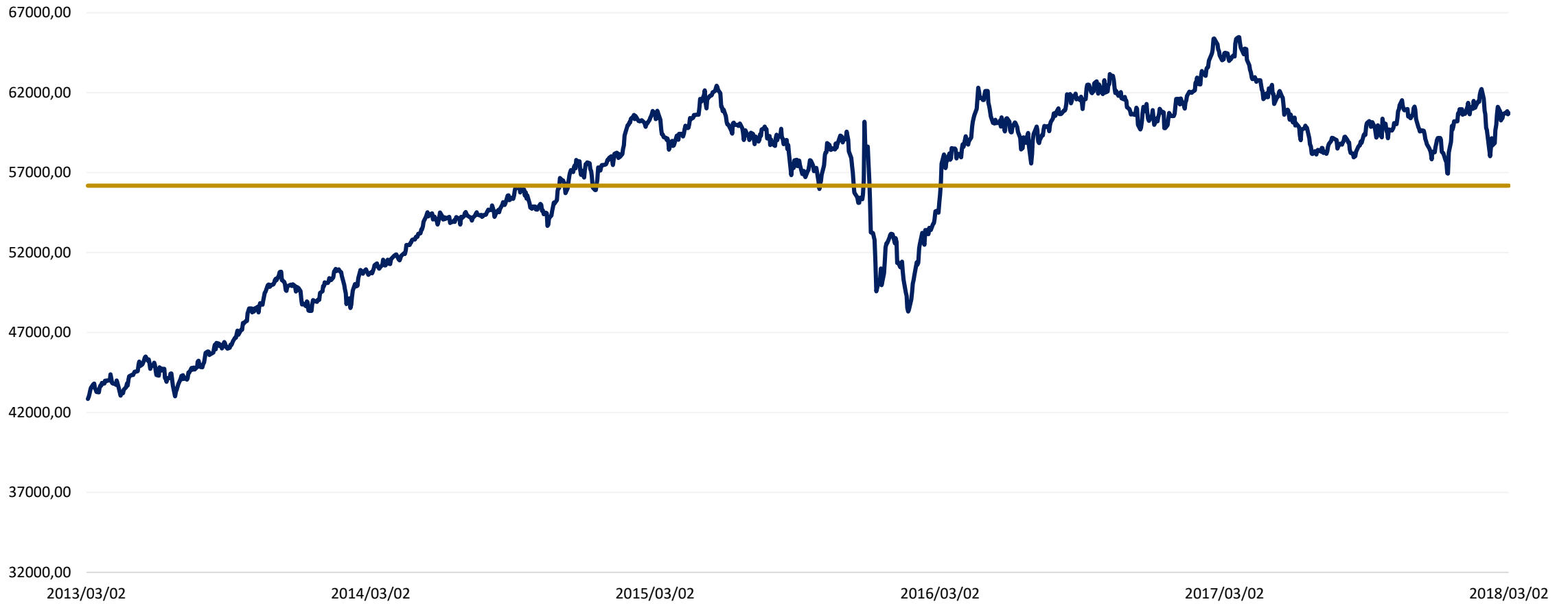

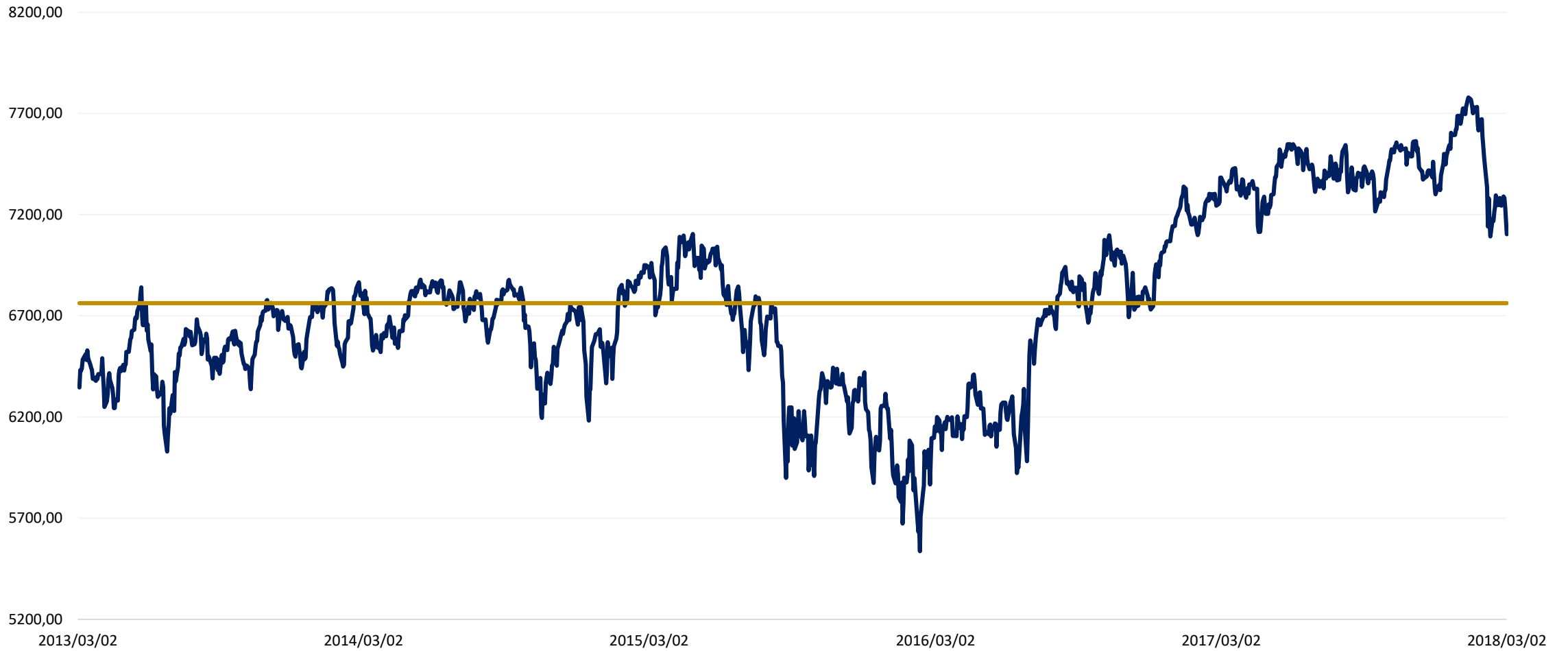

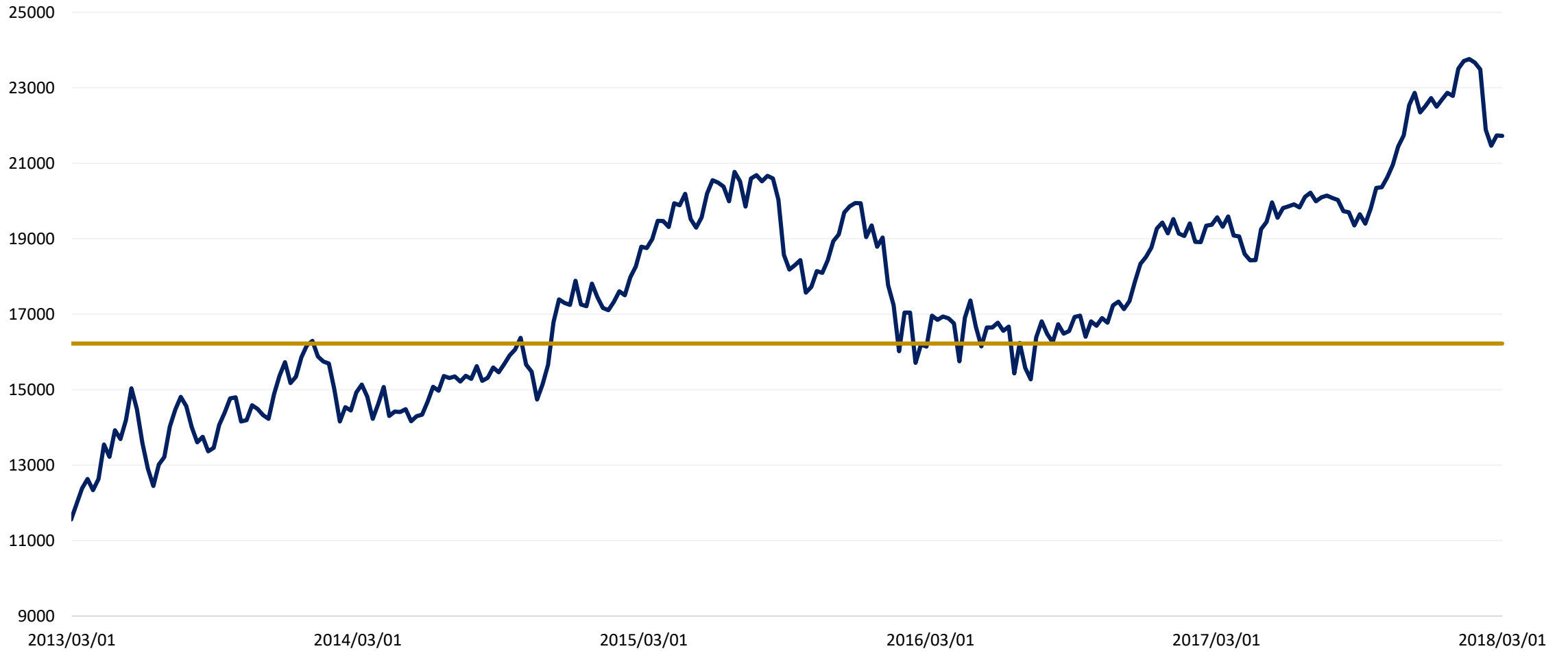

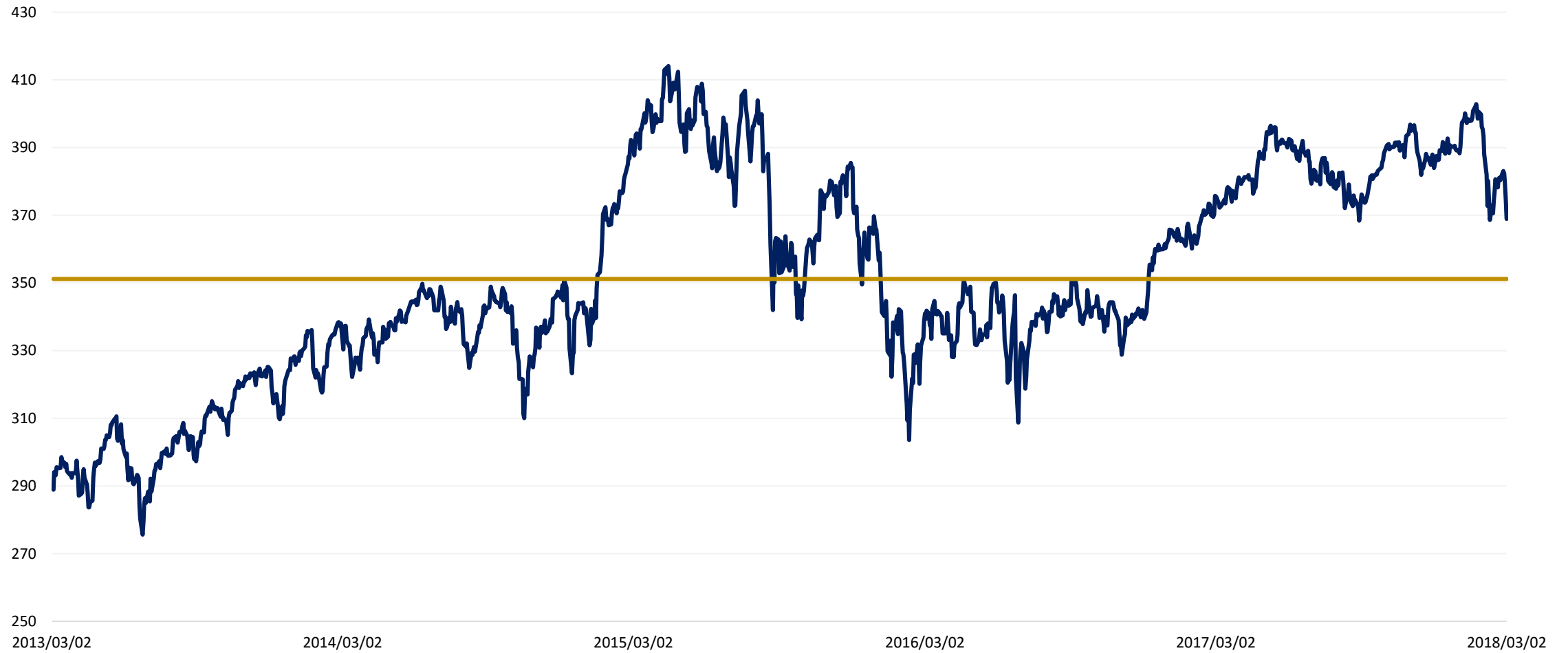
