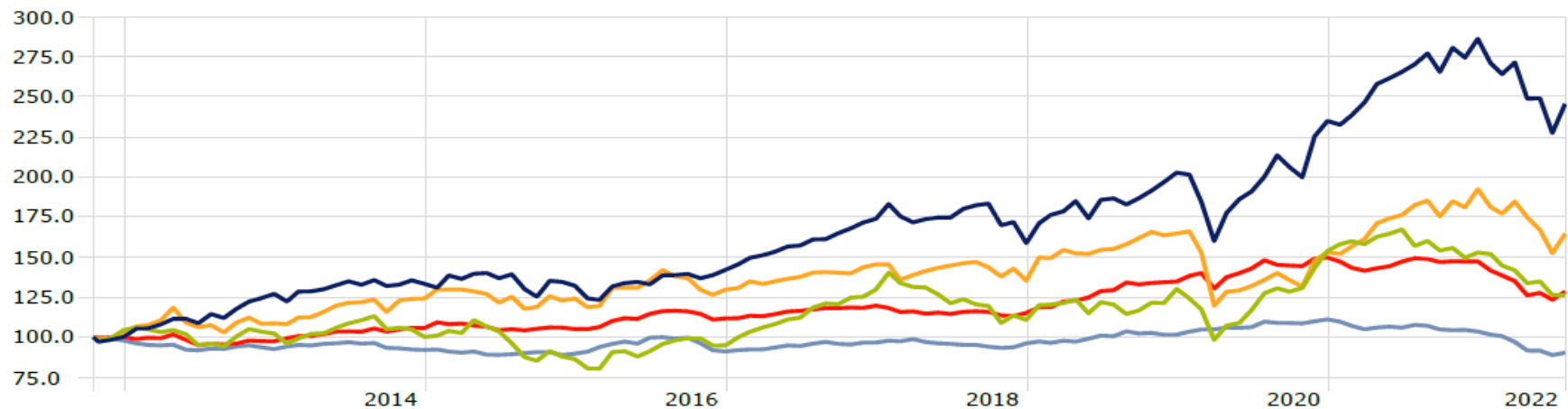

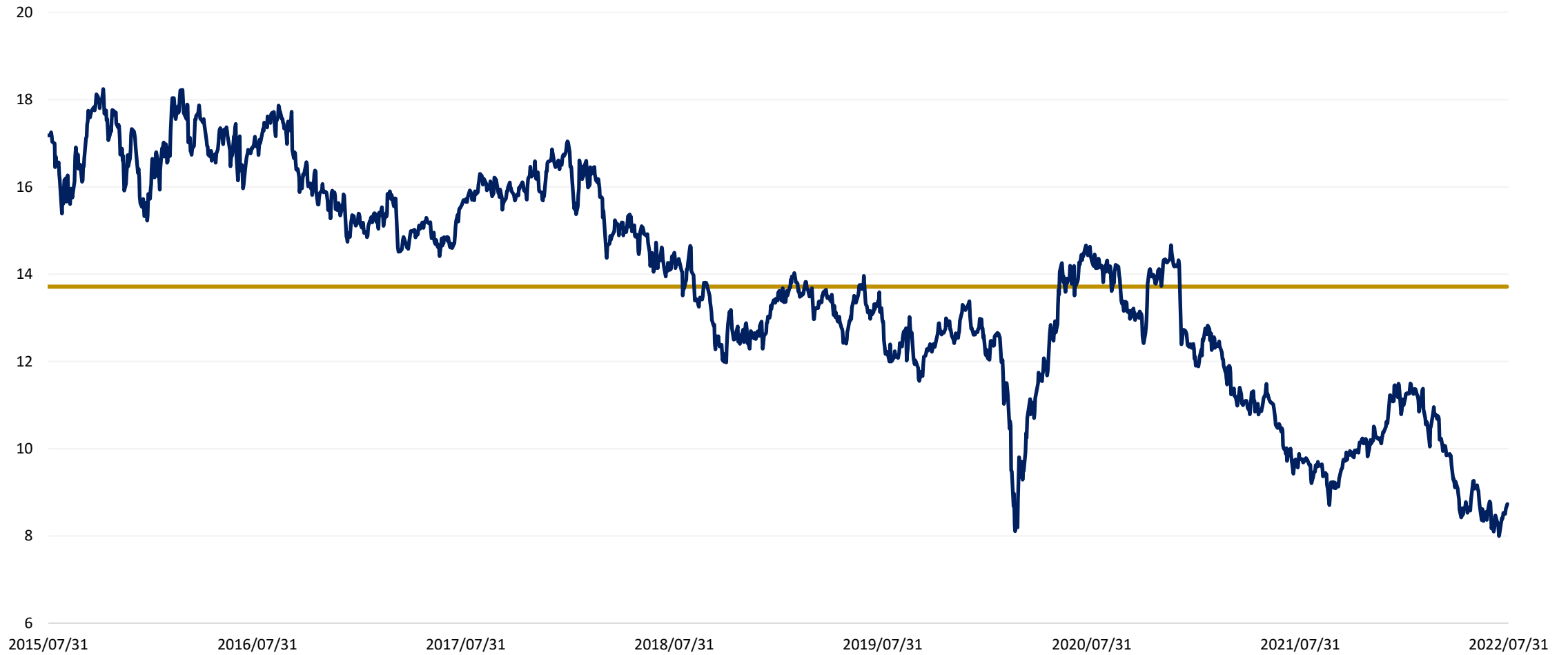

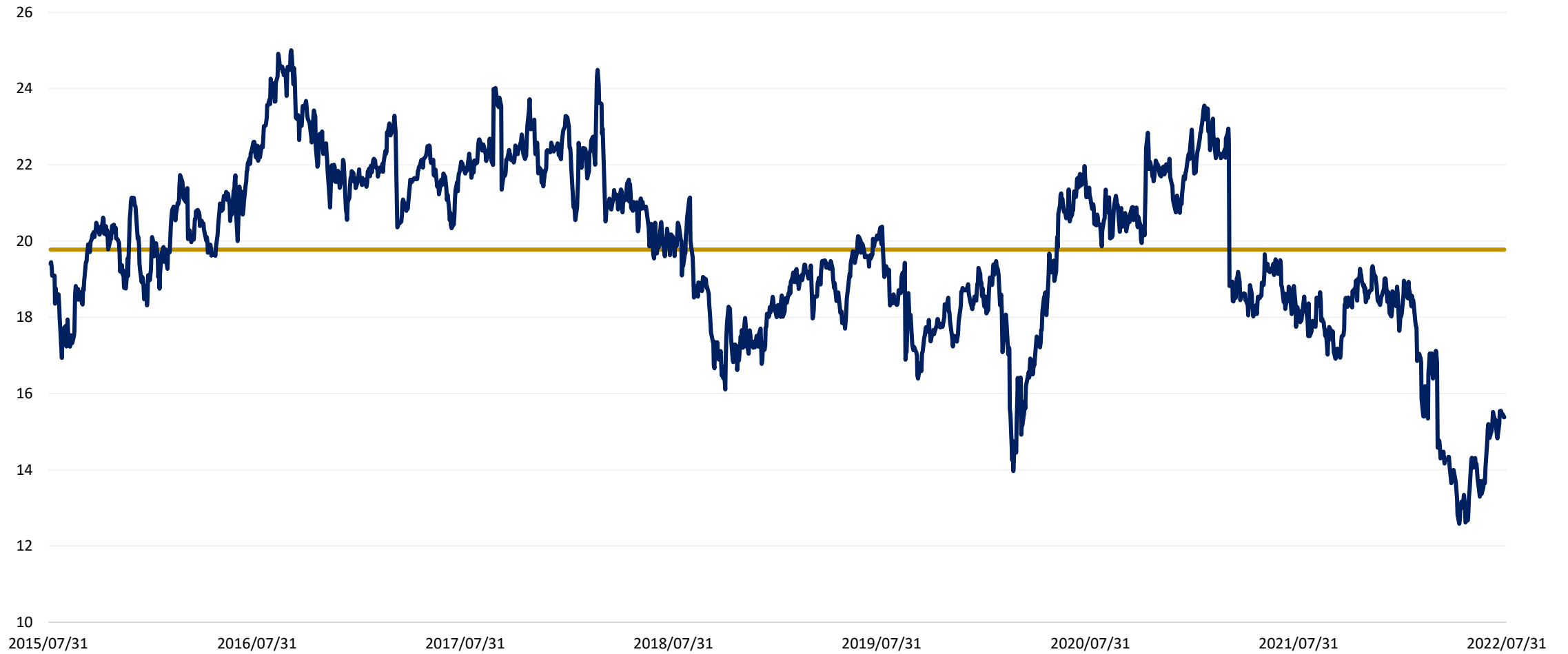

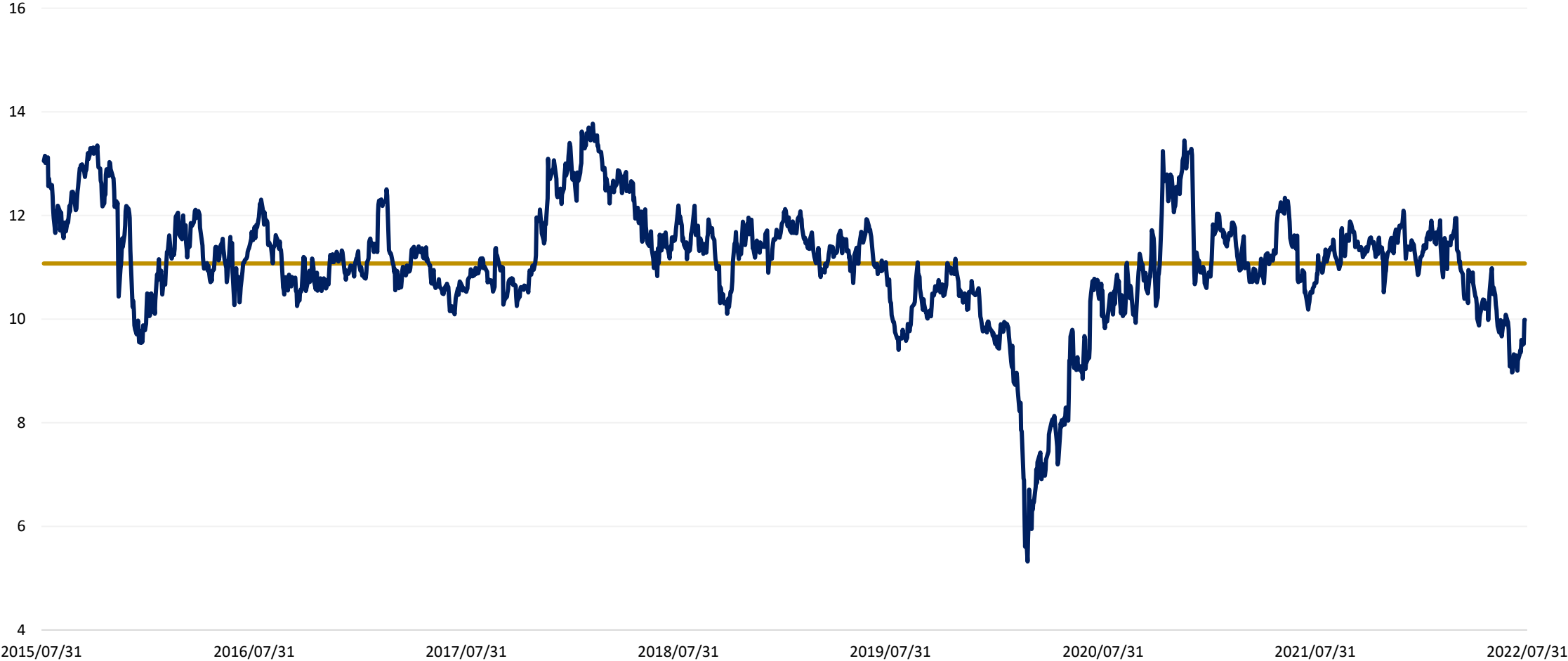

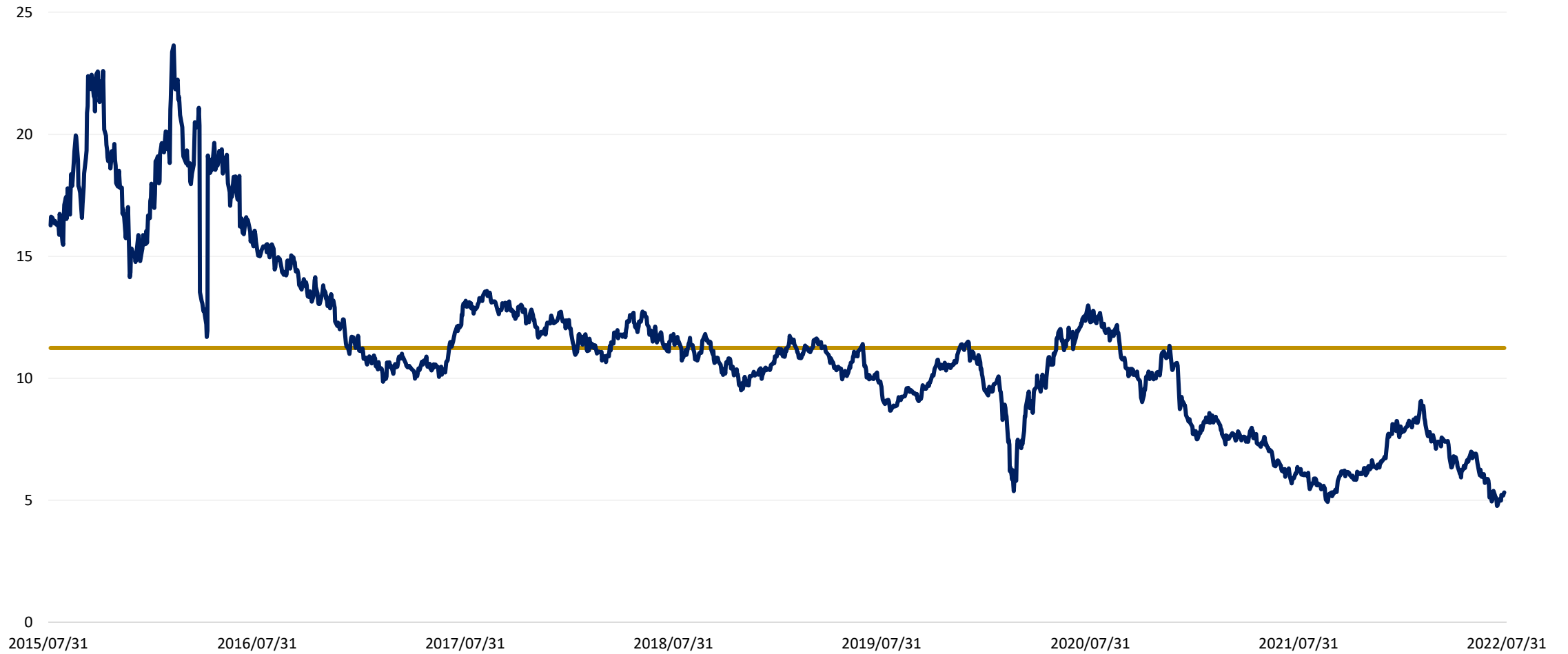

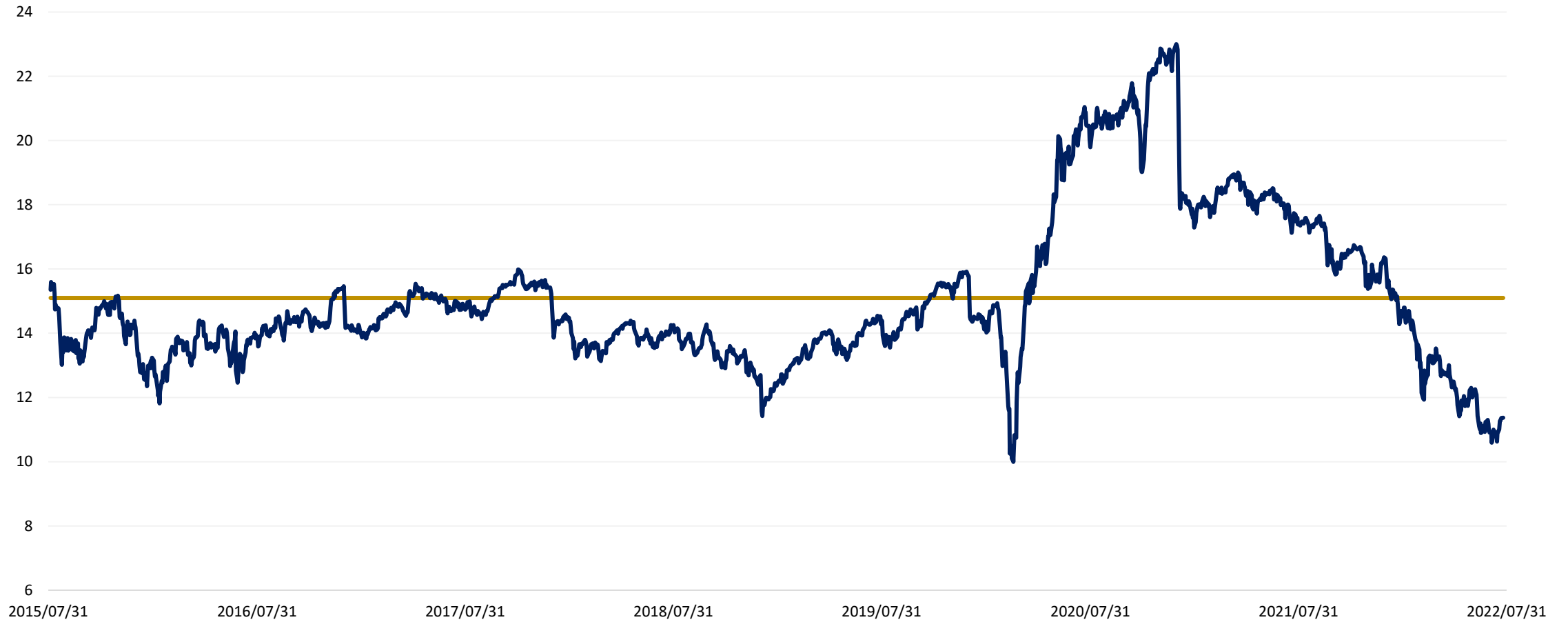

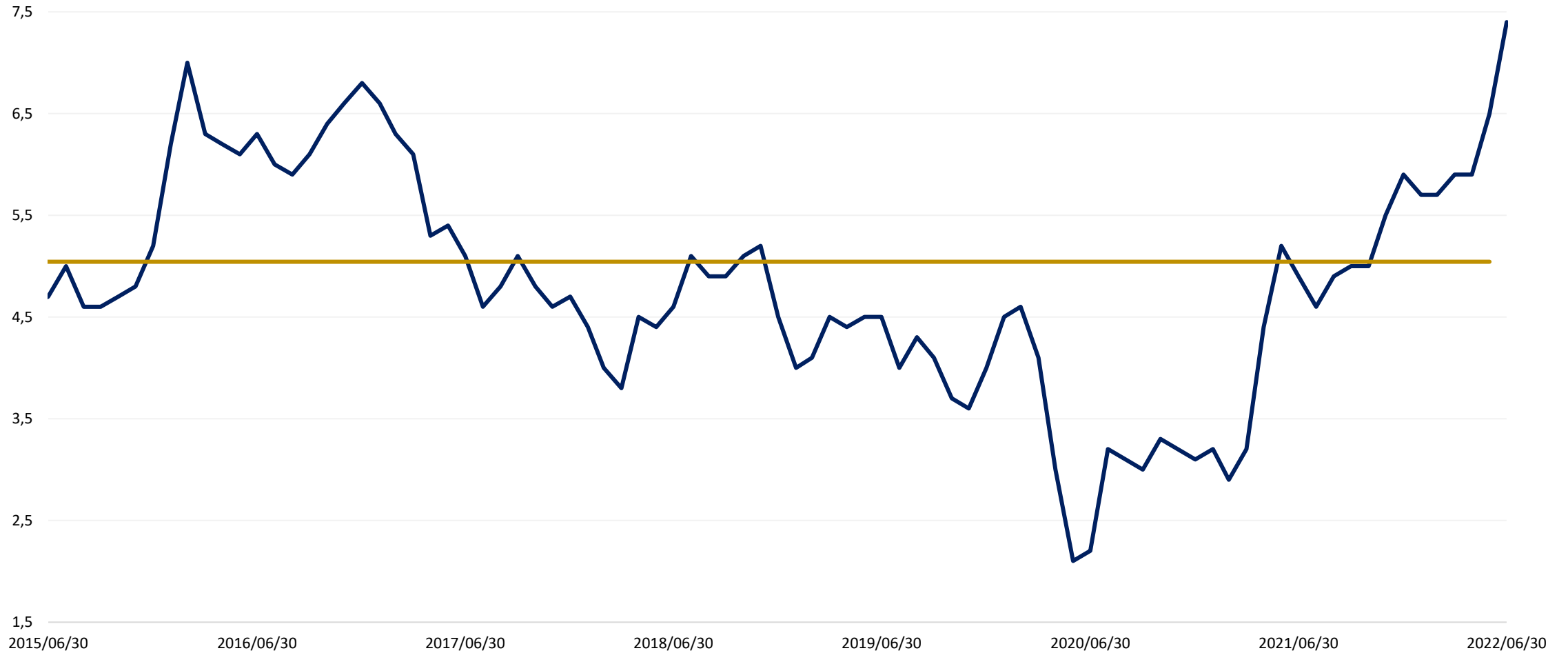

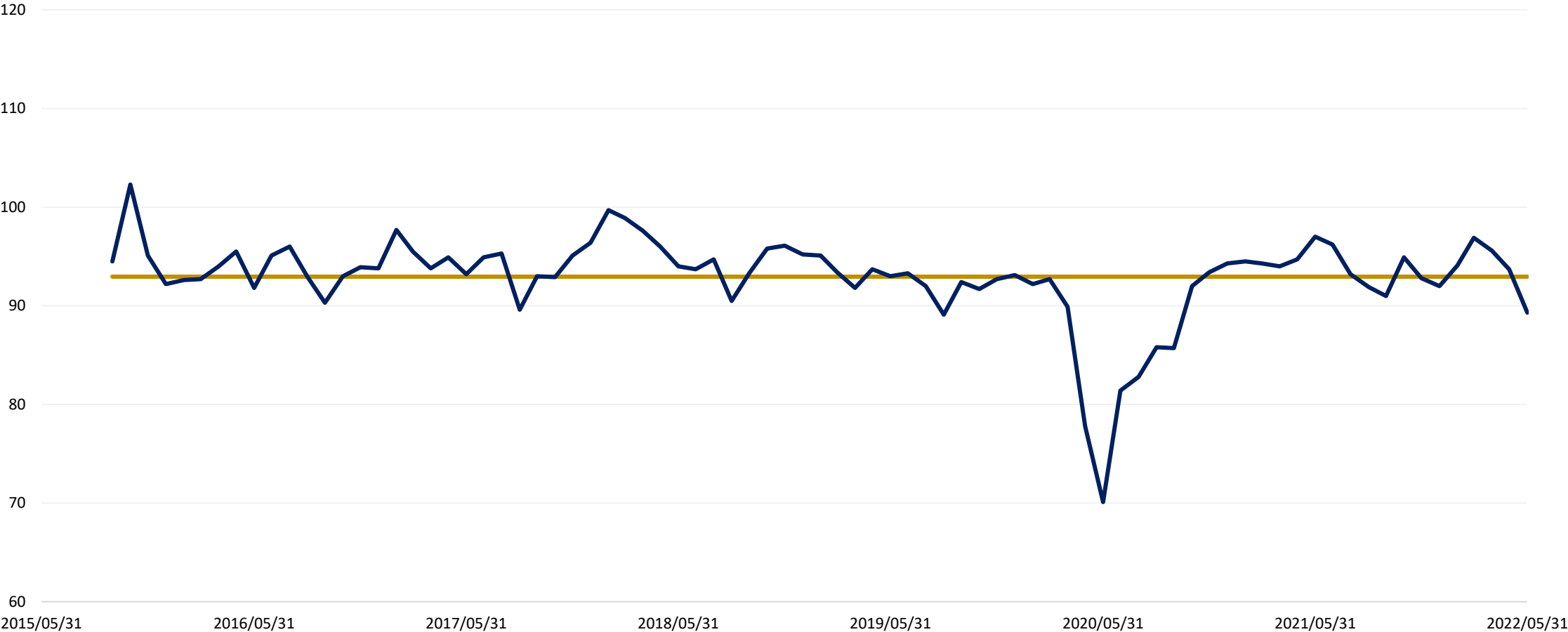

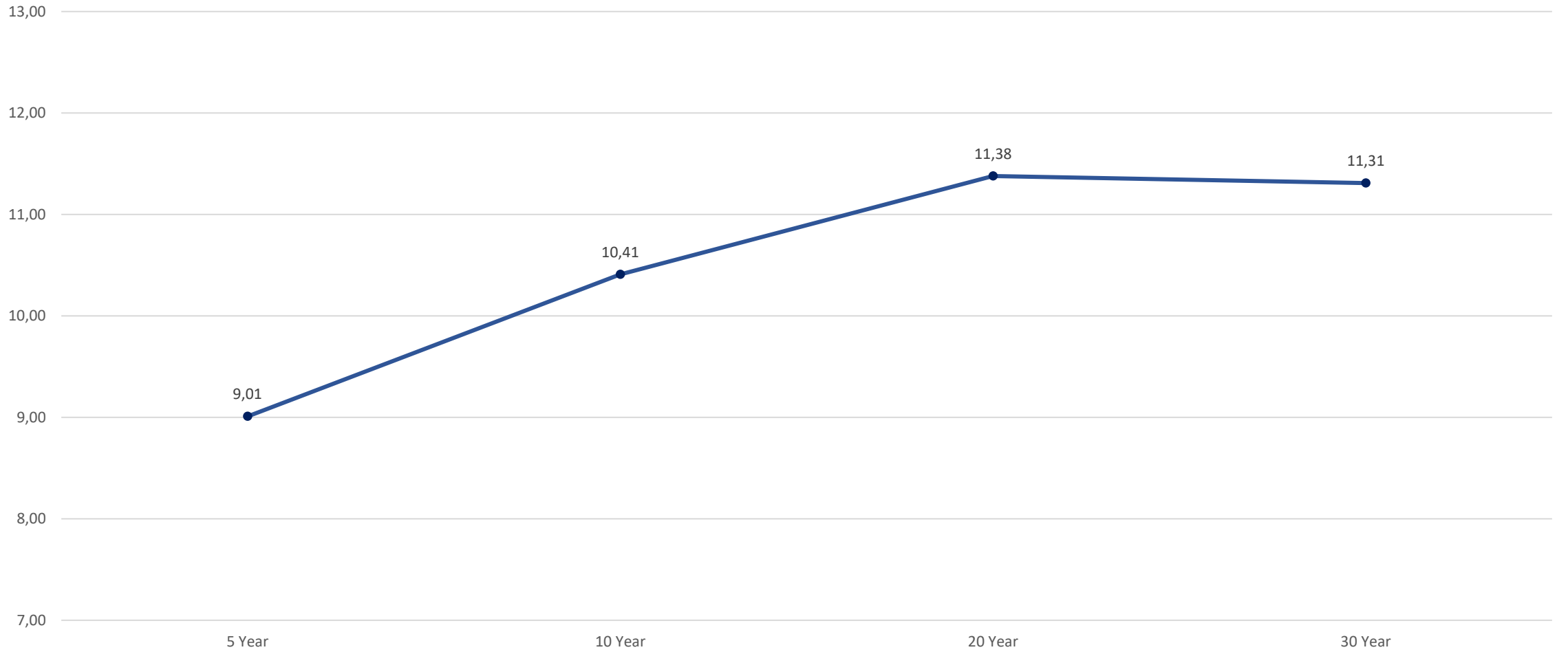
SA Retail Sales YoY Growth (%)

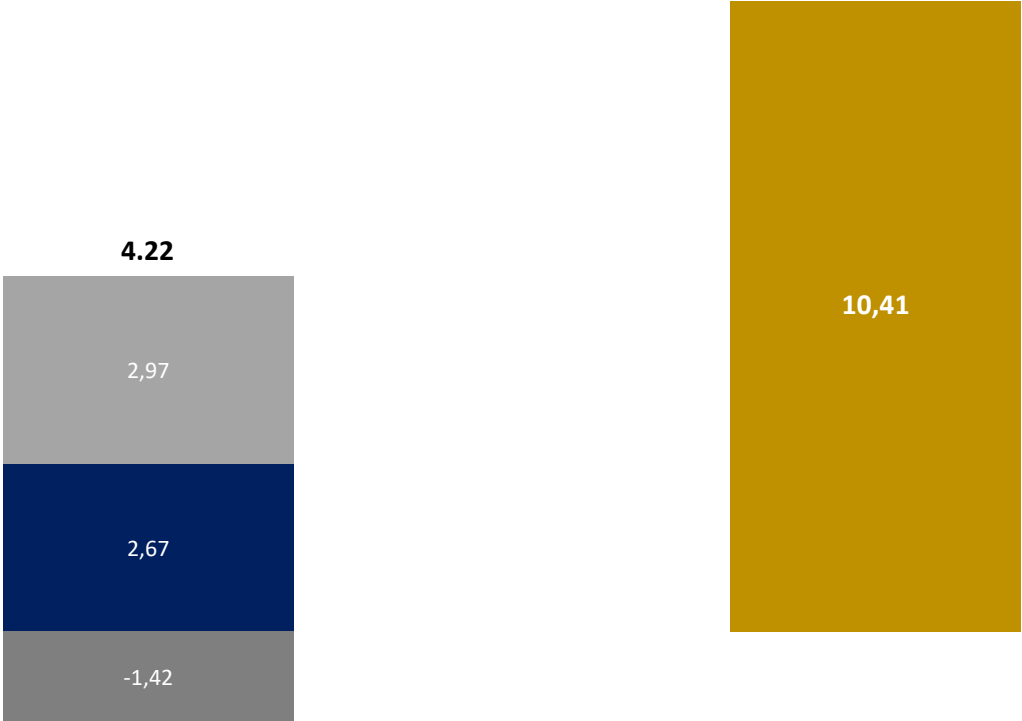


SA Bond Yields

Implied SA 10 Year Bond Yield vs Actual Yield



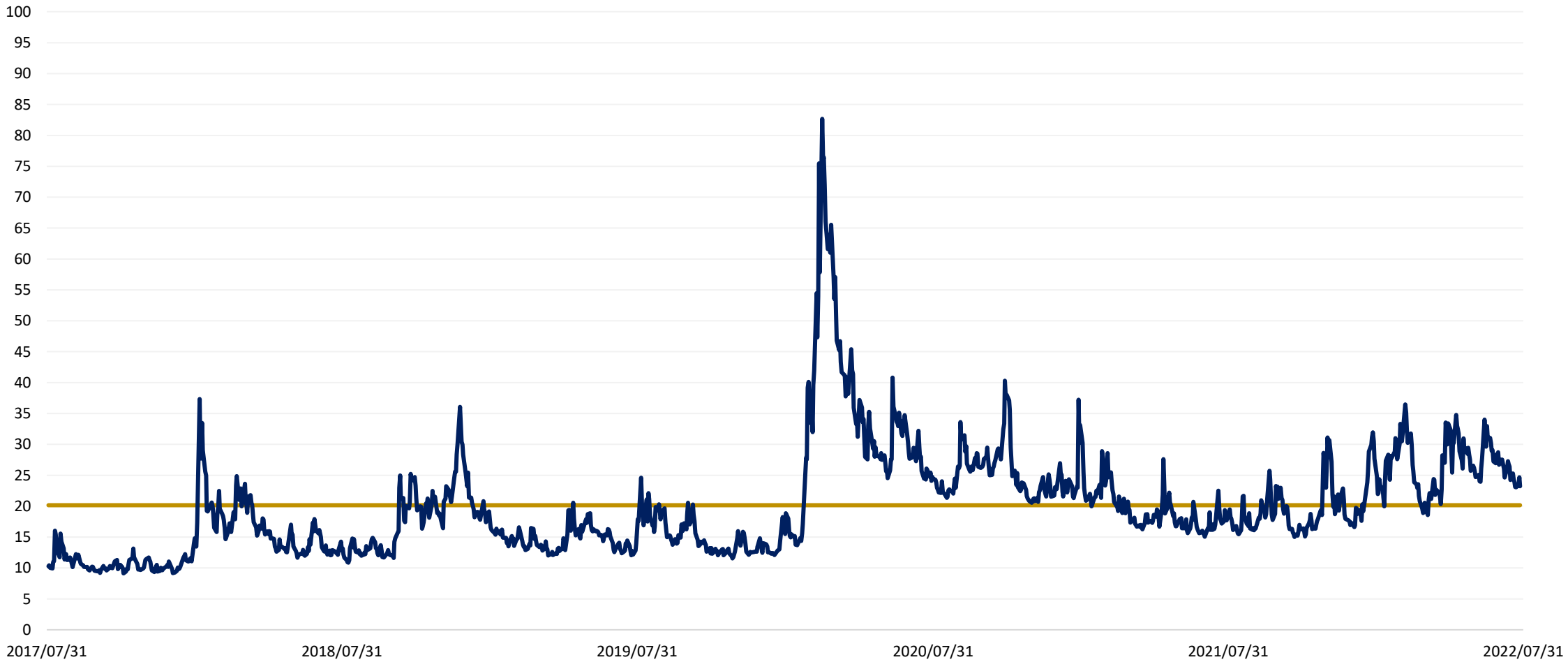

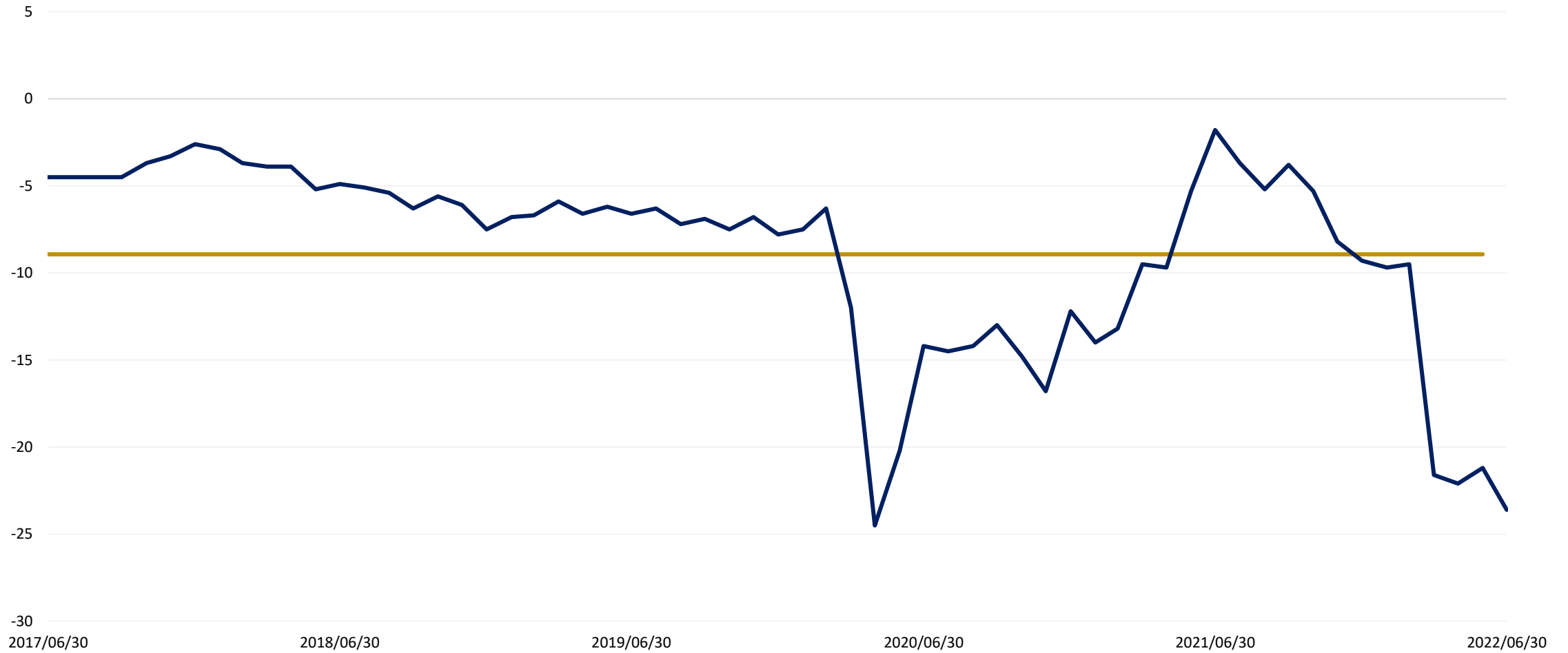
Market Volatility Index (VIX)

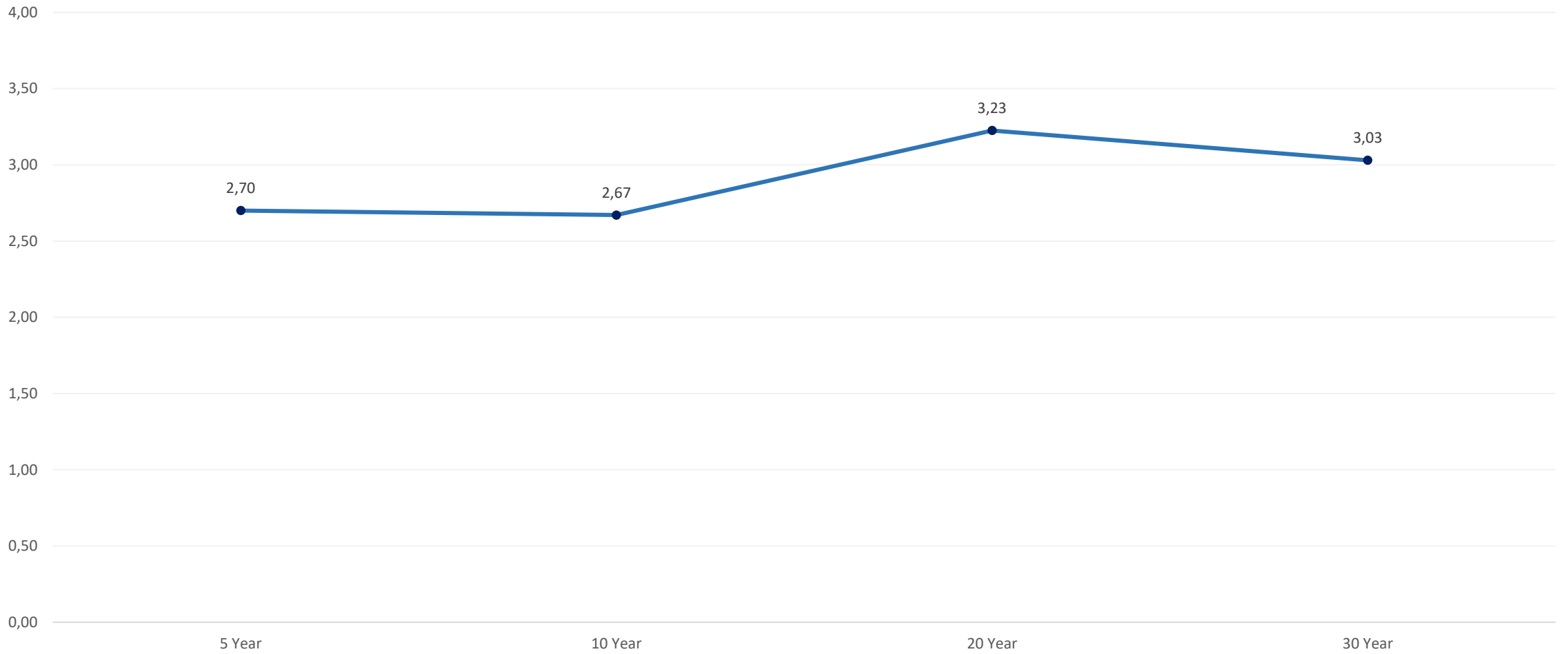
Eurozone - Consumer Confidence

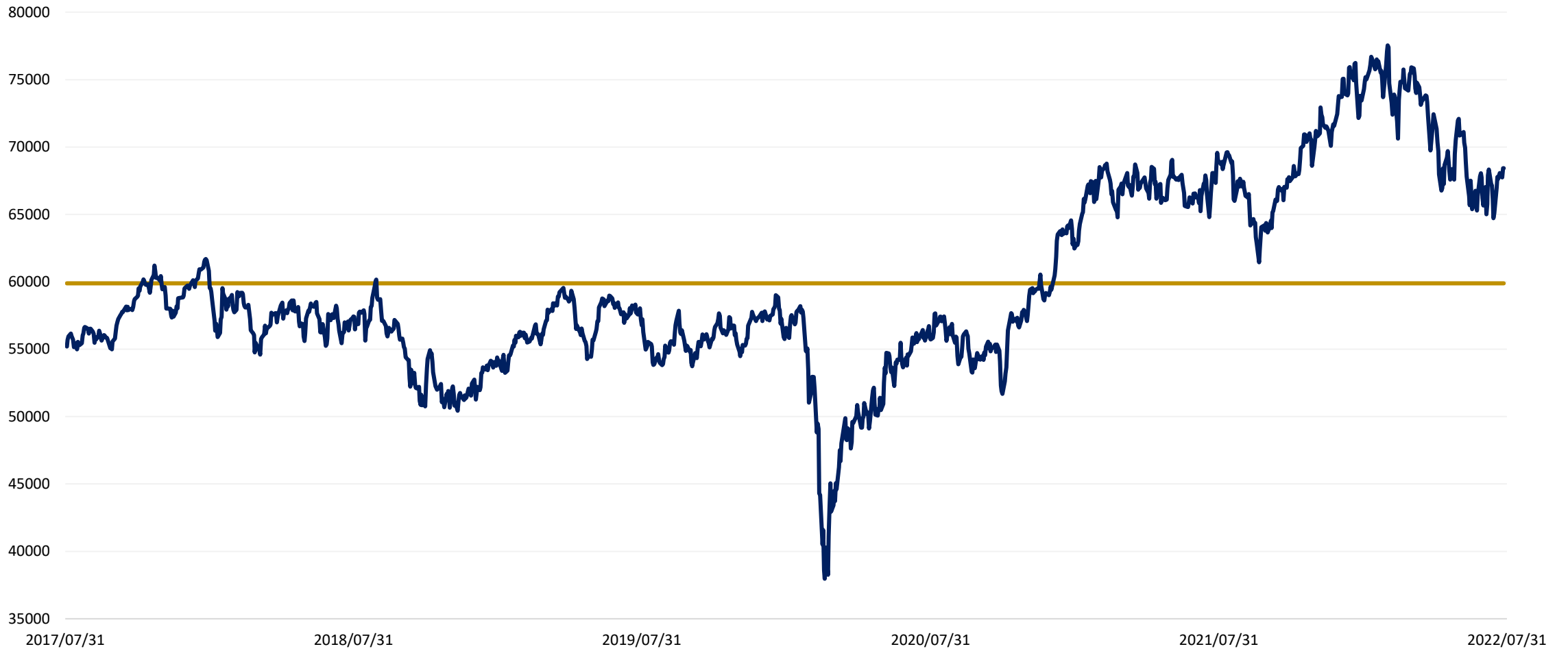
5 vs 10 vs 20 vs 30 Year Yields

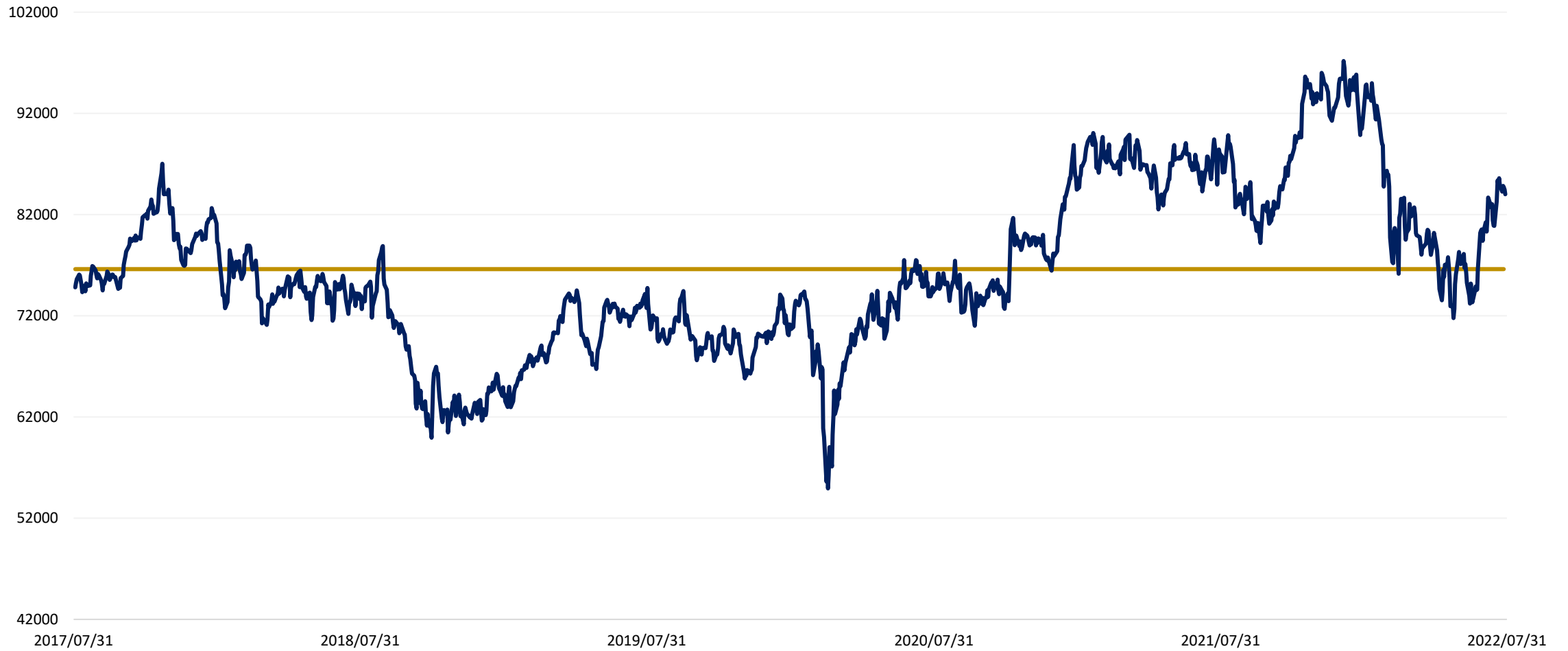

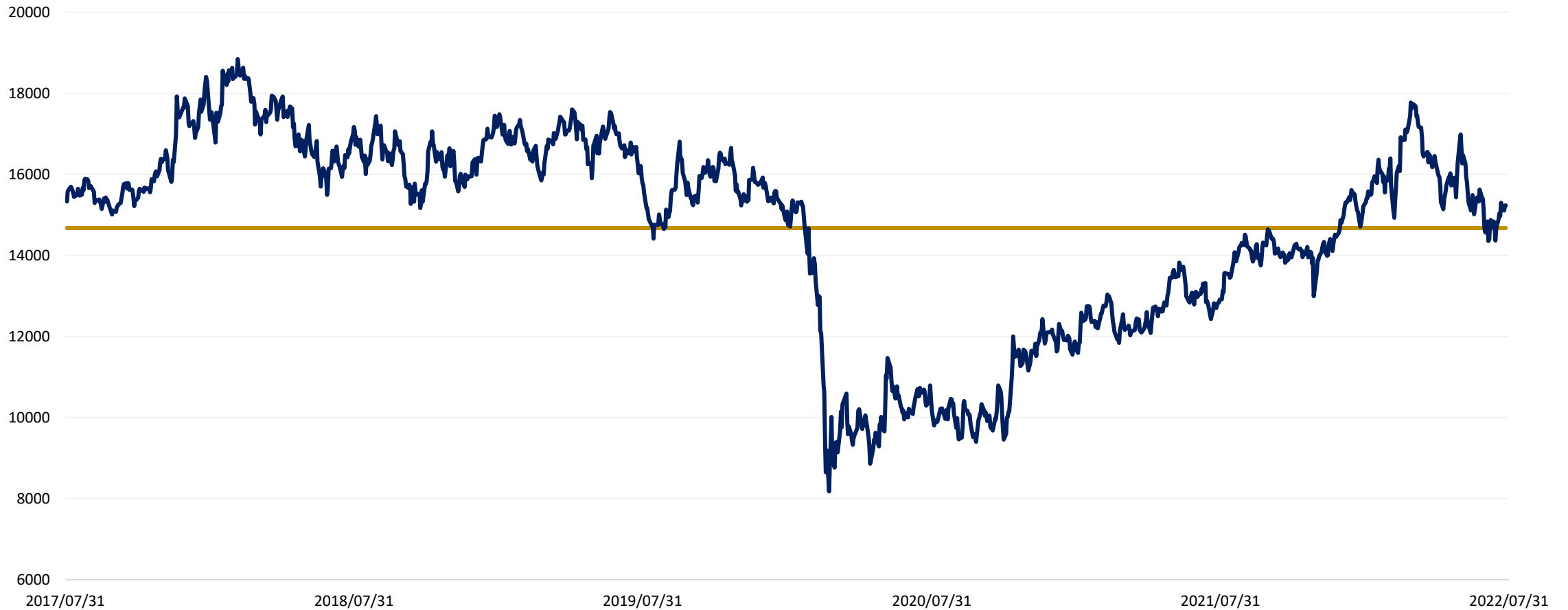

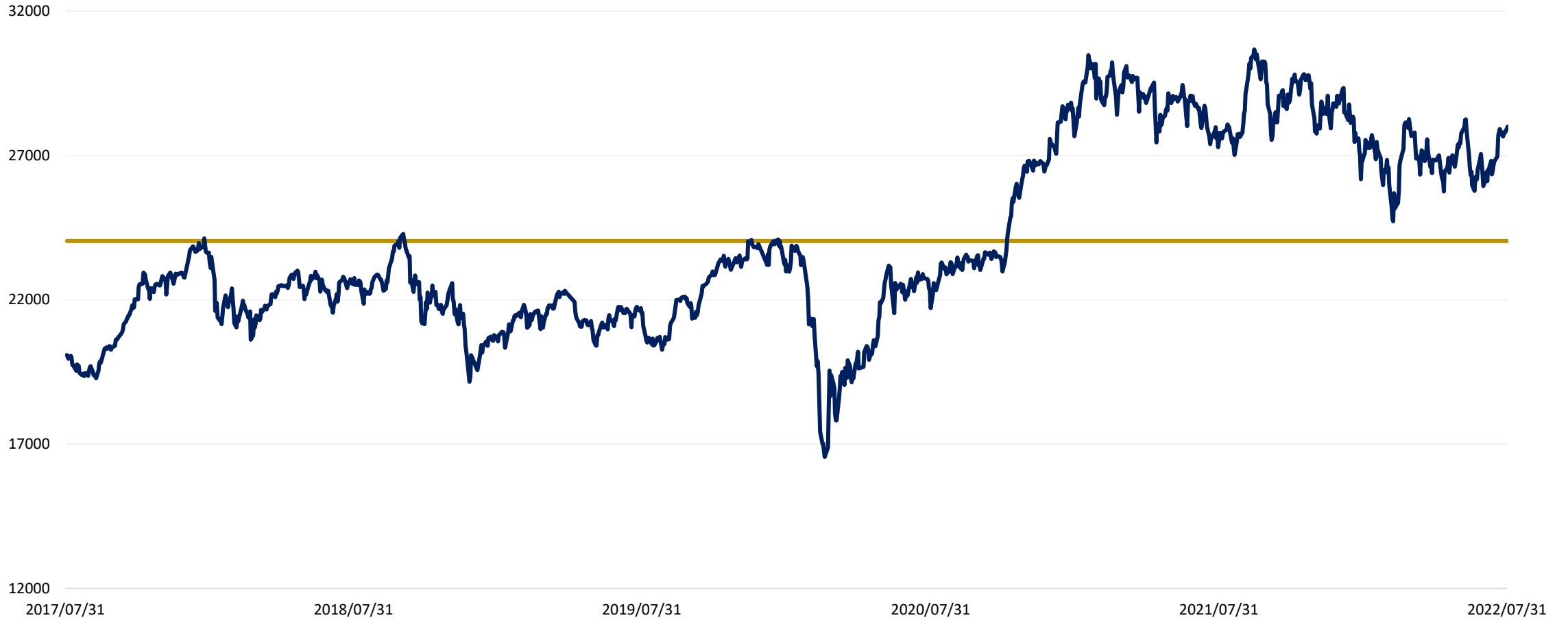
